No. 491 AN ORDINANCE AMENDING CHAPTER 886 BY APPROPRIATING

THE SUM OF SIXTEEN THOUSAND FIVE HUNDRED (\$16,500) DOLLARS TO  
A SPECIAL ACCOUNT TO BE KNOWN AS "PLEASANT VALLEY PARKWAY, BROOK  
REPAIR ACCOUNT".

Approved September 6, 1955

*Be it ordained by the City of Providence:*

SECTION 1: Chapter 886 of the Ordinances of the City of Providence as approved September 17, 1954, entitled: "An Ordinance Making Appropriation of \$30,448,534.47 for the Support of the City Government for the Fiscal Year Ending September 30, 1955", as amended, is hereby further amended by appropriating the sum of Sixteen Thousand Five Hundred (\$16,500) Dollars to an account to be known as, "PLEASANT VALLEY PARKWAY, BROOK REPAIR ACCOUNT".

SECTION 2: The said sum of Sixteen Thousand Five Hundred (\$16,500) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3: The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by Sixteen Thousand Five Hundred (\$16,500) Dollars.

SECTION 4: The City Controller and the City Treasurer are hereby authorized and directed to pay over this appropriation from the General Fund to an account in the Capital Funds to be known as "PLEASANT VALLEY PARKWAY, BROOK REPAIR ACCOUNT". Any unexpended balance remaining in this account upon completion of this work shall revert to the General Fund.

SECTION 5: This Ordinance shall take effect upon its passage.



No. **493 AN ORDINANCE** IN AMENDMENT OF CHAPTER 544 OF THE ORDINANCES OF THE CITY OF PROVIDENCE, APPROVED SEPTEMBER 21, 1951, AS HERETOFORE AMENDED, BY CHANGING FROM AN R-1 ONE-FAMILY ZONE TO A C-2 GENERAL COMMERCIAL ZONE, LOTS 17 and 18 FOR A DISTANCE OF ONE HUNDRED (100) FEET FROM PARK AVENUE AS SET OUT AND ~~DELINEATED ON CITY ASSESSOR'S PLAT 90;~~ SAID LOTS BEING LOCATED ON THE NORTHERLY SIDE OF PARK AVENUE NEAR PARK ROW.

*Be it ordained by the City of Providence:*

SECTION 1. The Zoning Map accompanying and made a part of Chapter 544 of the Ordinances of the City of Providence, approved September 21, 1951, as heretofore amended, and entitled "An Ordinance Zoning the City of Providence and Establishing Use, Height, and Area Regulations" <sup>is further amended</sup> by changing from an R-1 One-family Zone to a C-2 General Commercial Zone, Lots 17 and 18 for a distance of one hundred (100) feet from Park Avenue as set out and delineated on City Assessor's Plat 90; said lots being located on the northerly side of Park Avenue near Park Row, bounded and described as follows:

Beginning at a point in the northeasterly line of Park Avenue at the westerly corner of Lot 18 on Assessor's Plat 90; thence northeasterly along the northwesterly line of said Lot 18 to a point in a line one hundred (100) feet northeasterly from and parallel with the northeasterly line of Park Avenue; thence southeasterly along the said last described line, one hundred (100) feet northeasterly from and parallel with the northeasterly line of Park Avenue to the City Line; thence southwesterly along the said City Line to the northeasterly line of Park Avenue; thence northwesterly along the said northeasterly line of Park Avenue to the westerly corner of Lot 18 and the point and place of beginning.

SEC. 2. This Ordinance shall take effect upon its passage.



SUBJECT: Referral No. 708 - ZONING CHANGE ON THE NORTHERLY SIDE OF PARK AVENUE

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, May 24, 1955.

This referral is a request for a change in zoning from an R-1 Zone to a C-2 Zone of Lots 17 and 18 on Assessor's Plat 90 located on the northerly side of Park Avenue near Park Row. The lots in question contain a total of 19,970 square feet.

Reference is made to Referral No. 219, from the Committee on Ordinances, dated June 29, 1948, at which time a request was made to change the zoning to an apartment house use under the old Zoning Ordinance. It was recommended that the petition be denied. Subsequent action by the City Council granted leave to withdraw.

The increase in traffic would be considerable, and resulting congestion would decrease the value of the park for park purposes. It is important that the value of our parks be preserved. Both the increased visual and physical congestion resulting from the change in zoning would be very undesirable. A violation of the integrity of the park once made, leaves future violations that much easier. The policy should be upheld to preserve the values of Roger Williams Park.

Inasmuch as conditions in the area in question are substantially the same as the time of the previous referral,






