NO: 422 AN ORDINANCE IN AMENDMENT OF CHAPTER 778 of the CITY ORDINANCES OF 1953, ENTITLED: "AN ORDINANCE PROVIDING ADDITIONAL PAYMENTS TO RETIRED EMPLOYEES OF THE CITY OF PROVIDENCE", APPROVED SEPTEMBER 18, 1953.

Approved: July 13, 1967

BE IT ORDAINED BY THE CITY OF PROVIDENCE:

SECTION 1. Every retired employee of the City of Providence who served the City for at least twenty-five (25) years, or is now or hereafter receiving a retirement allowance from a City retirement system after at least twenty-five (25) years membership in such system prior to retirement or who was retired by a City retirement system because of a disability incurred as the result of an accident while in the performance of duty, shall receive from the City an additional sum of money which, when added to all personal service income received by such retired employee from any source whatsoever, and to any retirement, pension or social security allowance, shall assure to such employee, the sum of Two Hundred (\$200) Dollars per month. In the determination of the years of membership in a retirement system required by this section full credit shall accrue for any service prior to January 1, 1925, provided, however, the employee joined the City retirement system prior to January 5, 1926. Any employee, regardless of service, who was paid as of the date of retirement, a lump sum settlement in lieu of a retirement allowance, shall not be eligible for this grant.

SECTION 2. Amounts payable under the terms and provisions of this Ordinance shall be payable only to a retired employee during his lifetime, shall not survive the death of such employee and shall not be assignable, attachable, or transferable.

SECTION 3. For the purposes of this Ordinance the retirement allowance paid to such employee under any pension plan of the City shall be deemed the maximum service retirement allowance to which such employee would have been entitled and not any elected optional retirement allowance.

SECTION 4. Each retired employee eligible for payments under the terms of this Ordinance shall file monthly with the City Controller on or before a designated date, an information return in such form and detail as the Controller may require. No monthly benefits shall be paid until receipt of such return.

SECTION 5. Any wilful or material misstatement in the information return may render the person filing the same permanently or temporarily ineligible for benefits as the City Controller in his discretion may determine.

SECTION 6. The payments herein provided are purely voluntary and may be reduced or terminated at any time as to any or all persons receiving the same.

SECTION 7. Chapter 778 of the City Ordinances of 1953 is hereby repealed.

SECTION 8. This Ordinance shall take effect upon passage.

AGREEMENT dated this day of
A.D. 1967, by and between the CITY OF PROVIDENCE, a municipal
corporation, organized by act of the General Assembly,
party of the first part, and FEDERAL HILL HOUSE ASSOCIATION,
a Rhode Island corporation, party of the second part;

WHEREAS, the party of the second part is the owner of a
certain parcel of land situated at the southeasterly corner of
Hewitt Street and Atwells Avenue in the City and County of
Providence, State of Rhode Island, and further described as Lot
159 on City Assessor's Plat 28; and

WHEREAS, the party of the first part wishes to develop this
parcel of land as a park for the inhabitants of the City of
Providence; and

WHEREAS, the party of the second part deems it advantageous
to itself to have said parcel developed as a park and to use said
parcel as so developed in conjunction with its recreational
activities.

NOW, THEREFORE, in consideration of the mutual promises
hereinafter set forth, the parties hereto agree as follows:

1. The party of the first part shall develop said parcel of
land as a public park.
2. After the completion of the development of said parcel
of land as a public park, the party of the second part shall at
its own expense maintain said parcel as a public park.
3. The party of the second part shall make no alterations to
said parcel or any improvements thereon made by the party of the
first part without first obtaining written consent of the party
of the first part.

4. The party of the second part shall permit the party of the first part, its agents and servants, at all reasonable times to enter upon the premises so as to view the condition of the same.

5. The party of the second part will save the party of the first part harmless from any liability by reason of personal injuries to any person or persons on or about the premises, and agrees that the party of the second part will carry indemnity insurance as against the said liability in a sum not less than FIVE THOUSAND (\$5,000) DOLLARS, with offices satisfactory to the party of the first part.

IN WITNESS WHEREOF, the CITY OF PROVIDENCE and the FEDERAL HILL HOUSE ASSOCIATION have caused these presents to be signed and their corporate seals hereunto affixed by one of their officers duly authorized, the day and date first above written.
