

RESOLUTION OF THE CITY COUNCIL

No. 398

Approved June 9, 1993

RESOLVED, DECREED AND ORDERED:

That the following named street shown as cross-hatched area on the accompanying plan entitled: "Providence, RI Department of Public Works - Engineering Office, Street Line Section Plan No. 064541 dated March 2, 1993."

VIZ:

SOMERSET STREET, (portions of), shown as cross-hatched area on accompanying plan and designated by the letters (A-B-C-D-A) having ceased to be useful to the public and is proposed to be abandoned as a Public Highway. Said Abandonment is specifically conditioned precedent upon the following: (1) The City Plan Commission of the City of Providence shall indicate its approval of the within abandonment by letter to the Office of the City Clerk, City of Providence. (2) Petitioner shall tender the amount of One Hundred Sixty Thousand Dollars (\$160,000.00) in legal tender U.S. to the City of Providence. (3) The petitioner shall convey an easement acceptable to the Narragansett Electric Company which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the petitioner that any such facilities need be relocated in order to comply with an intended use, the petitioner shall assume all costs of relocation. (4) The petitioner shall convey an easement acceptable to the Providence Water Supply Board which will permit retention of its facilities in their existing location together with the right to inspect, maintain, operate and replace the same and with twenty-four access to said facilities or upon the election of the Providence Water Supply Board pay the sum of Two Thousand Seven Hundred Four and 31/100 (\$2,704.31) to provide for the relocation of said facilities, and the damage to the abutters is appraised at nothing and so awarded. And it is further

ORDERED, That the Traffic Engineer be and he is hereby directed to cause a sign to be place on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper, published in the County of Providence at least once a week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.





PETITION TO THE CITY COUNCIL

TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

The undersigned respectfully petitions your honorable body

to abandon a portion of Somerset Street, beginning at the easterly line of Prairie Avenue and continuing easterly to the westerly line of Gay Street. The subject area is shown crosshatched on the enclosed plan entitled "Plan of Proposed Abandonment of a Portion of Somerset Street in the City of Providence, R.I. by R.A. Cataldo Engineering, Pawtucket, Rhode Island Scale 1" = 80' September 3, 1992".

The Rhode Island Hospital complex is undergoing a major expansion and upgrading. The hospital planning staff has retained the services of R.A. Cataldo Engineering to analyze the effects these improvements will have upon the transportation system surrounding the hospital.

Rhode Island Hospital realized the need for additional parking. A parking study revealed the current system can not meet the demands of employees, patients and visitors. The abandonment of Somerset Street will create additional parking spaces with the reconfiguration of the hospital lots adjacent to Somerset Street.

Traffic volumes were collected for AM and PM peak travel periods along Somerset Street as well as its adjacent streets namely Pearl Street, Dudley Street and Blackstone Street. It was found that Somerset Street maintains the lowest traffic volumes of these four roadways between Prairie Avenue and Gay Street. Conclusions drawn from existing traffic patterns are listed as follows:


1. Somerset Street maintains low through volumes with the majority of traffic utilizing the roadway for on street parking and access/egress to the adjacent parking lots.
2. Adjacent streets will accommodate the shift in traffic patterns due to the abandonment of Somerset Street without reducing service levels.
3. Emergency vehicles will not be affected as the remaining roadway grid provides ample routes for emergency vehicles.
4. The hospital will gain a net of 100 parking spaces with the reconfiguration of the existing lots and the abandonment of Somerset Street.

In summary, Rhode Island Hospital, owning the property on both sides of Somerset Street for the entire length of the proposed abandonment, would realize much needed additional parking while creating no significant adverse impacts on existing traffic operations.


1. Somerset Street maintains low through volumes with the majority of traffic utilizing the roadway for on street parking and access/egress to the adjacent parking lots.
2. Adjacent streets will accommodate the shift in traffic patterns due to the abandonment of Somerset Street without reducing service levels.
3. Emergency vehicles will not be affected as the remaining roadway grid provides ample routes for emergency vehicles.
4. The hospital will gain a net of 100 parking spaces with the reconfiguration of the existing lots and the abandonment of Somerset Street.

In summary, Rhode Island Hospital, owning the property on both sides of Somerset Street for the entire length of the proposed abandonment, would realize much needed additional parking while creating no significant adverse impacts on existing traffic operations.



The Rhode Island Hospital complex is undergoing a major expansion and upgrading. The hospital planning staff has retained the services of R.A. Cataldo Engineering to analyze the effects these improvements will have upon the transportation system surrounding the hospital.

Rhode Island Hospital realized the need for additional parking. A parking study revealed the current system can not meet the demands of employees, patients and visitors. The abandonment of Somerset Street will create additional parking spaces with the reconfiguration of the hospital lots adjacent to Somerset Street.

Traffic volumes were collected for AM and PM peak travel periods along Somerset Street as well as its adjacent streets namely Pearl Street, Dudley Street and Blackstone Street. It was found that Somerset Street maintains the lowest traffic volumes of these four roadways between Prairie Avenue and Gay Street. Conclusions drawn from existing traffic patterns are listed as follows:

1. Somerset Street maintains low through volumes with the majority of traffic utilizing the roadway for on street parking and access/egress to the adjacent parking lots.
2. Adjacent streets will accommodate the shift in traffic patterns due to the abandonment of Somerset Street without reducing service levels.

Gentlemen:

The City Plan Commission at its March 17, 1993 regular monthly meeting reviewed and evaluated the proposed abandonment of eastern portion of Somerset Street from Prairie Avenue to Gay Street.

The petitioner is Rhode Island Hospital represented by Ralph A. Cataldo Engineering, who prepared a petition for the aforesaid abandonment. According to the petition, the hospital will gain a net of 100 parking spaces with the reconfiguration of the existing lots and the abandonment of Somerset Street.

A field inspection revealed that aforesaid portion of Somerset Street is a paved public right-of-way with sidewalks and underground utilities.

Somerset Street as well as adjacent streets -- namely, Pearl Street, Dudley Street and Blackstone Street provide vehicular and pedestrian access to the Women and Infants Hospital and Rhode Island Hospital complex.

Somerset Street also provides access/egress to the adjacent parking lots owned by Rhode Island Hospital.


