




RE: REQUEST FOR APPRAISED VALUE

Pursuant to your request for an appraisal of property at 35 and 50 Potters Avenue, the following is submitted for your information.

Surveys conducted by this office indicate the properties located in areas between Eddy and Cahill Streets to Prairie Avenue from Public, through to Harriet and Mystic Streets, generally are selling in a range of 20¢ to 80¢ per square foot.

Keeping everything in proper perspective, it is the opinion of this office at a 3,200 sq. ft. lot would have a value of approximately 54¢ per sq. foot or ~~\$1,500~~ to ~~\$1,700~~.
