AN ACT

IN AMENDMENT OF SECTION 1 OF CHAPTER 838 OF THE PUBLIC LAWS, 1940, AS AMENDED
BY SECTION 6 OF CHAPTER 2723 OF THE 1951 PUBLIC LAWS.

It is enacted by the General Assembly as follows:

SECTION 1. Section 1 of Chapter 838 of the Public Laws, 1940, entitled "An Act Authorizing the Bureau of Police and Fire of the City of Providence to Make Rules and Regulations Governing the Granting of Sick Leave to Employees of Such Bureau", as amended by Section 6 of Chapter 2723 of the Public Laws, 1951, is hereby further amended to read as follows:

"Section 1. The commissioner of public safety of the City of Providence shall make suitable rules and regulations governing the granting of sick leave to patrolmen, firemen and other employees of such departments. In addition, sick leave may be granted where some member of the immediate family of such patrolman, fireman or other employee, is afflicted with a contagious disease and where his presence in the service would jeopardize the health of fellow employees. Sick leave shall be granted at the rate of fifteen days a year, and if unused, may be accumulated up to a period of ninety (90) days; provided, however, that any employee of the police and fire departments with at least ten (10) years of continuous service who contracts a serious illness may be granted with the approval of the commissioner of public safety and the finance director a further leave of ninety (90) days in addition to his accumulated sick leave as of the date said illness occurs."

SEC. 2. This act shall take effect upon its passage, and all acts and parts of acts inconsistent herewith are hereby repealed.

WHEREAS certain areas of Blackstone Park, in the vicinity of Patterson Street, have ceased to be useful for park purposes, and the Board of Park Commissioners has consented to the sale thereof,

NOW THEREFORE BE IT RESOLVED, That His Honor the Mayor is hereby authorized to convey to The Outlet Company approximately 177,857 square feet of land, being portion of Lot 14 on Assessor's Plat 41, Blackstone Park, adjoining Patterson Street in the City of Providence, to be used for the erection of a building to contain the studios of Station WJAR-TV and Station WJAR-AM, television and radio stations owned and operated by The Outlet Company, said area of land being delineated on a certain contour map of the property entitled, "Contour Map for WJAR in Providence, R. I. by J. A. Latham & Son Engr's. Dec. 1954, Scale 40 feet per inch". The proposed sale is to be contingent upon the result of test borings to determine whether or not suitable foundations for building purposes may be found upon the property, and also that the consent of the proper bodies of government may be obtained for the erection of the facilities. The purchase price for said property shall be the sum of \$125,000.00

The petitioner requests to purchase 177,857 square feet of land, or approximately 4 acres, located in the southerly end of Blackstone Park and fronting on Paterson Street. A radio and television building, 200' x 240', is proposed to be located 120 feet east of Paterson Street. This part of the park is largely unused.

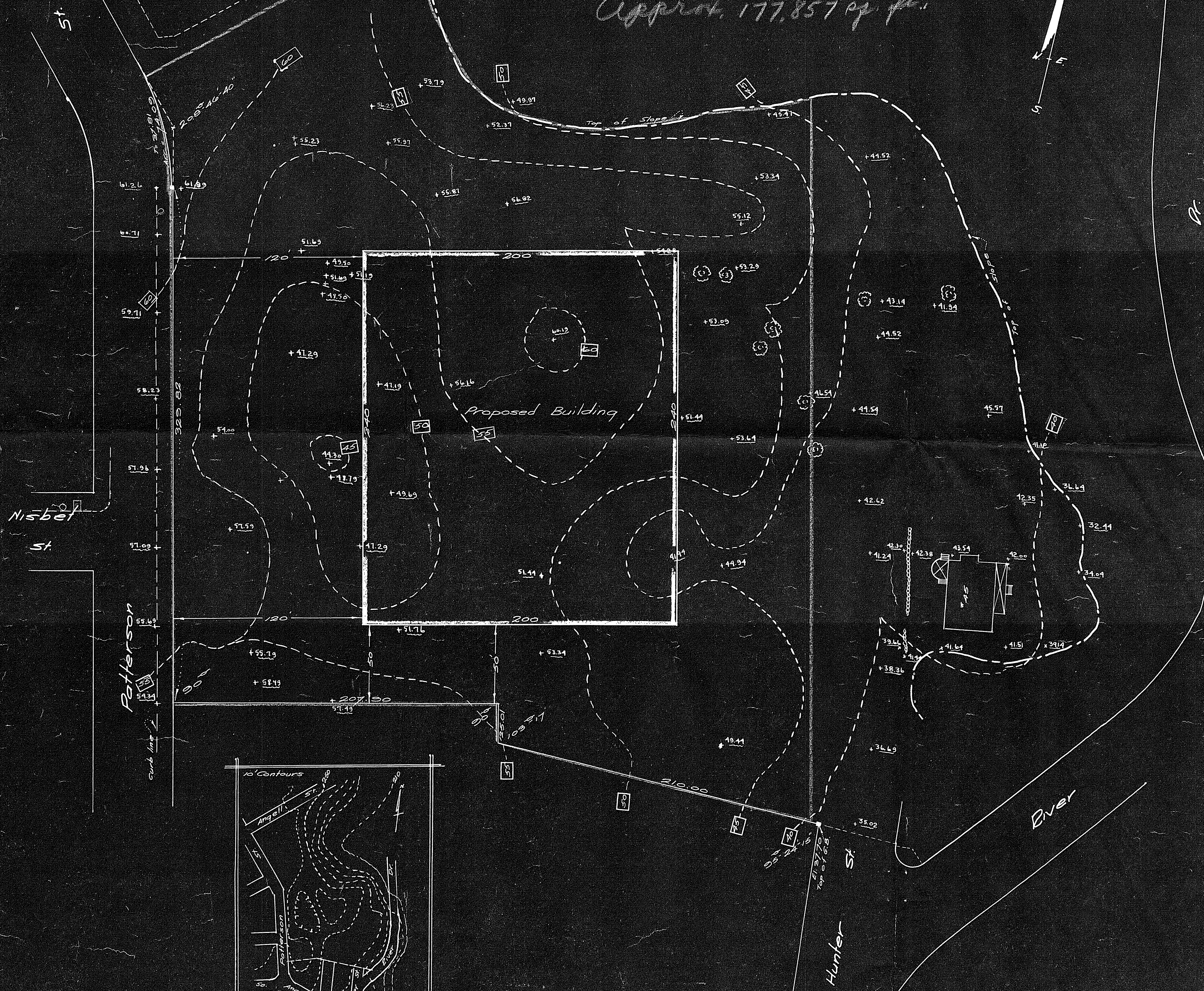
