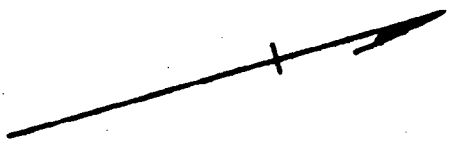

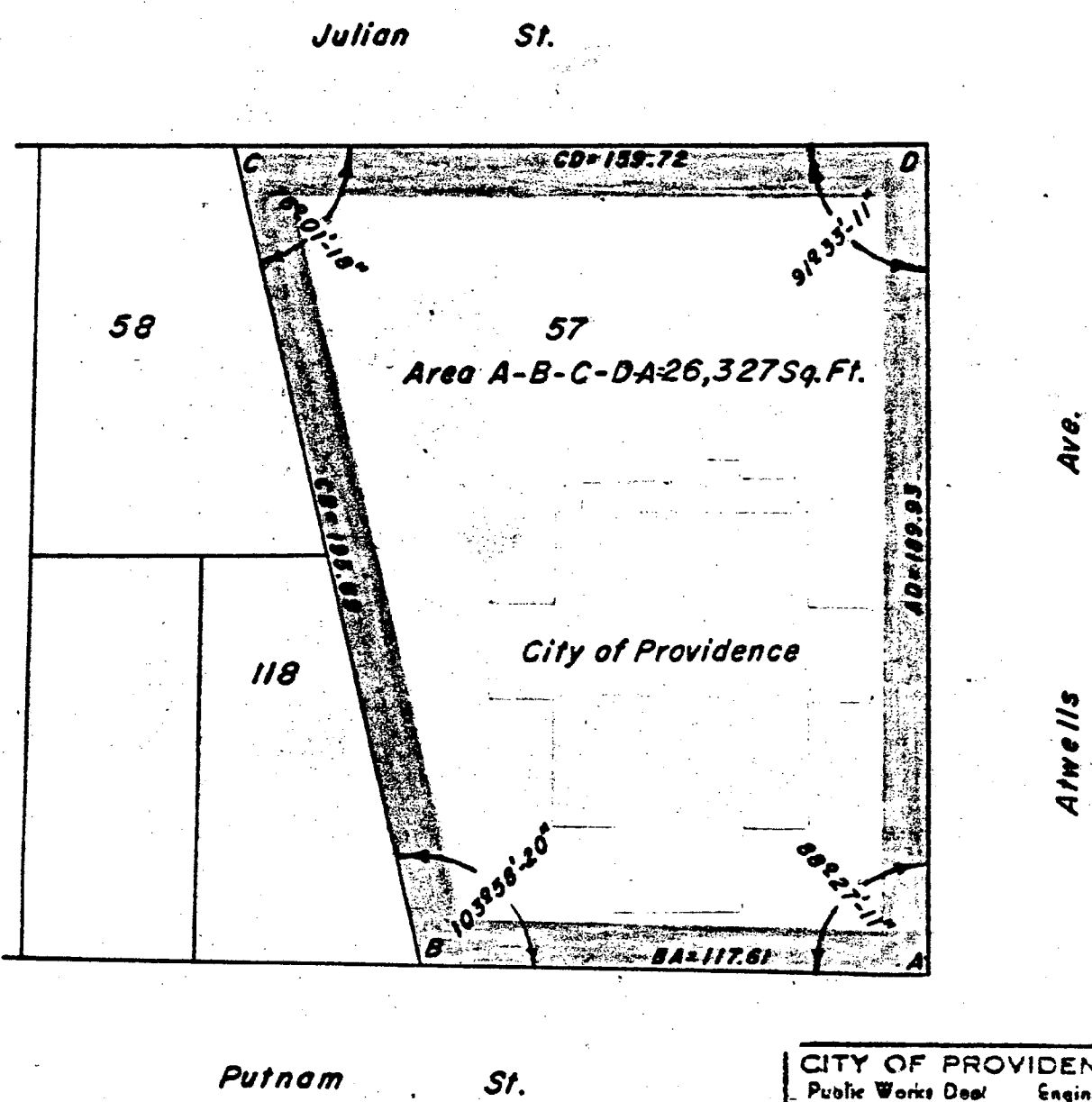

I have read the article in The Providence Journal on Tuesday, January 19, 1982 concerning the veto of the land sale at the site of the former Fogarty School.


As stated in my original offer in correspondence to the Committee on October 12, 1981; the three thousand dollar (\$3,000) amount was considered equitable in light of substantial expenses in razing the structure and making the land suitable for a parking lot. At that time I had no knowledge of any intention by the City of Providence to raze the building at their expense. This has just recently been done.

I am still very interested in this parcel of land. In light of recent developments, I would like to submit a new offer to the Committee.

I am willing to pay the valuation price for this property of seven thousand six hundred dollars (\$7,600) as well as the expenses to the City for razing the structure of six hundred dollars (\$600.00).

I hope you will give this matter your serious consideration and a favorable response.
