This Department will bait sewers upon requests from constituents. Any property experiencing rodent problems should call this Department at 467-7950 and an Environmental Inspector will determine whether baiting the adjacent sewers is a panacea to the problem. Additionally, working with the Mayor's Office, a Total Pesticide Management program is on-going whereby greater enforcement, garbage containment, baiting, cleaning lots and sewer lateral capping are being employed to control the rodent population.

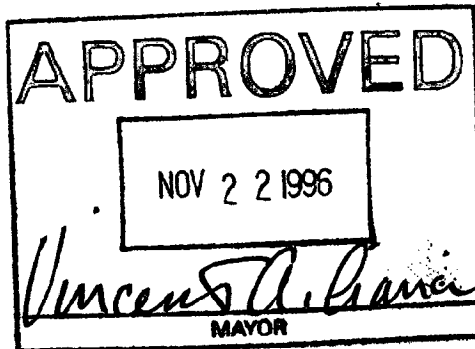

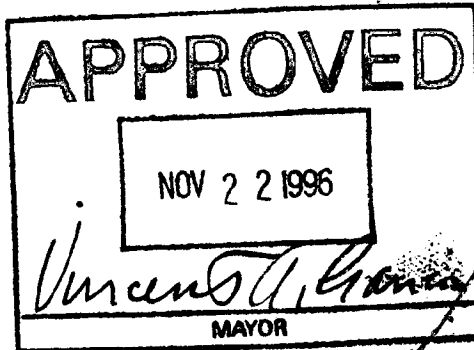
