AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1983-30 APPROVED JULY 10, 1983, BY TRANSFERRING THE SUM OF FORTY FOUR THOUSAND THREE HUNDRED FIFTY DOLLARS (\$44,350.00) FROM THE PURCHASING DEPARTMENT MOTOR FUEL ACCOUNT (1-005-17-211) TO BOARD OF CANVASSERS (1-009-04) VARIOUS LINE ITEMS AS AMENDED.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1983-30 of the Ordinances of the City of Providence, as approved July 10, 1983, entitled: "An Ordinance making Appropriation of One Hundred Ninety-Six Million, Seven Hundred Ninety-Six Thousand, Two Hundred Forty Dollars and Ninety-Six Cents (\$169,796.96) for the Fiscal Year ending June 30, 1983, as amended", is hereby further amended by transferring the sum of Forty-Four Thousand Three Hundred Fifty Dollars (\$44,350.00) from the Purchasing Department Motor Fuel Account (1-005-17-211) to the Board of Canvassers (1-009-04) as follows:
