At a meeting of the Zoning Board of Review held on Monday, April 27, 1959, the following resolution was adopted:

WHEREAS, Fred Colossano, owner of Lot 324 on Assessor's Plat 113 (427 Hartford Avenue) in a Commercial C-4 Zone, on March 9, 1959, filed an application to be relieved from the corner setback requirements in the proposed erection of twin sign poles having a combined diameter of more than 8" in order to erect an 8' in diameter rotating sign, and

WHEREAS, a public hearing was held on this application by the Zoning Board of Review at its meeting held on Tuesday, April 21, 1959, after public notice as provided by the Zoning Ordinance,

RESOLVED: That the Zoning Board of Review does hereby make a variation of the corner setback requirements under the Zoning Ordinance and does hereby grant the application of Fred Colossano substantially in accordance with the plans and plot plan filed with said Board.
