Approved March 8, 1963

WHEREAS, Charles F. McLroy relinquished his post as Director of Public Works on February 28, 1963 after more than twenty-two years of dedicated service. Courtesy, integrity and ability enabled him to compile an enviable record in public relations. His example could well be emulated by all city employees to the betterment of the city and its people, and

WHEREAS, in the course of events, with a nature such as his, it was inevitable that he became civic minded. He chose to espouse the doctrines of the Democratic Party which he has been championing ever since that night many years ago, when, too young to vote, he made his maiden political speech. A candidate, nettled by Charlie's heckling and hoping to silence him by inviting him up on the rostrum, was taken back when Charlie accepted. His experience as a debater for English High School made him the winner that night and he has been winning ever since. He headed the Providence Democratic City Committee in the early '30s and he left here to become Director of Public Works of the State during the years from 1935 through 1938, and

WHEREAS, as State Director of Public Works in September of 1938 when the devastating Hurricane and Tidal Wave occurred, he directed the herculean task of rehabilitation. Efficient without being officious, he brought order out of chaos in an unbelievably short time. He gave repeat performances in the City of Providence when the hurricanes of 1944, 1954, 1955 and 1960 struck, and

WHEREAS, he has been Chairman of the Providence Democratic City Committee since 1940, and no doubt, will remain so, as long as he chooses. It is generally conceded that his party's long list of uninterrupted victories is due in no small measure to his personal sagacity and political acumen, and

WHEREAS, his private life while replete with good deeds, only the recipients of his generosity, kindnesses and understanding will ever know the extent of his charity. A widower for many years, he does take justifiable pride in the fine family he has reared; his two daughters are contented members of religious orders, his three sons are enjoying successful careers in their chosen fields and have provided him with fourteen grandchildren to carry on his good name.

NOW, THEREFORE, BE IT RESOLVED, that His Honor, Mayor Walter H. Reynolds and the members of this city council join with his legion of friends to acknowledge their deep debt of gratitude to Charles F. McLroy for his many years of conscientious public service with the fond hope that he will be blessed with good health for many years to enjoy his well earned retirement.

WHEREAS, Mayor Walter H. Reynolds and the members of this City Council have noted with sincere regret the death of Thomas A. Cahir on February 27, 1963, and

WHEREAS, Mr. Cahir had a long and varied career in government having served two terms in the State Legislature prior to being elected to the Common Council from the 4th Ward in 1930. He was returned to office at the 1932 election and on January 2, 1933 was chosen President of the Common Council, a position he held until March 5, 1934 when he resigned to accept appointment as a member of the Board of Canvassers and Registration. Except for the period from December of 1939 to March of 1941 - during a change in administration - he served continuously until his retirement in May of 1961, the last twenty years of which, he was its Chairman, and

WHEREAS, he was a native of Providence and a resident of the North End where his community efforts gained him a host of friends. He was an avid sportsman - a participant in his youth and a spectator for the rest of his life. He took an active part in the affairs of the Immaculate Conception Parish and was one of its trustees for many years until the West River Industrial Park came into being. For the past six years he has been a resident of the Elmhurst section and a communicant of St. Pius Church.

NOW, THEREFORE, BE IT RESOLVED, that members of this city council now record their tribute to the memory of Thomas A. Cahir; directing the City Clerk to transmit to his widow and family a duly certified copy of this resolution.
