This ordinance constitutes the City's declaration of official intent pursuant to Treasury Regulation Section 1.150-2 to reimburse the City's General Fund for certain capital expenditures for the leased equipment paid on or after the date which is sixty (60) days prior to the date of this ordinance, but prior to the issuance of the lease purchase agreement. Such amounts to be reimbursed shall not exceed \$20,000,000, and shall be reimbursed not later than eighteen (18) months after (a) the date on which the expenditure is paid, or (b) the date the Project is placed in service or abandoned but in no event later than three (3) years after the date the expenditure is paid.

PRESENTATION OF RESOLUTIONS

COUNCIL PRESIDENT MATOS, COUNCILWOMAN ANTHONY, COUNCILMEN CORREIA, ESPINAL, COUNCILWOMEN MILLER, CASTILLO, HARRIS, COUNCILMAN IGLIOZZI, COUNCILWOMAN LAFORTUNE, COUNCILMAN SALVATORE, COUNCILWOMEN KERWIN, RYAN AND COUNCILMAN NARDUCCI

Resolution Supporting the expansion of SNAP benefits for online and delivery services.

WHEREAS, In January 2017, the United States Department of Agriculture's Food and Nutrition Service Agency, launched phase one of their EBT Online Purchasing Program with select retailers and states; and

WHEREAS, The only states currently participating in the EBT Online Purchasing Program are New York, Nebraska, Oregon, Iowa, Alabama, and Washington; and

WHEREAS, As Rhode Island is not currently included in the EBT Online Purchasing Program, Rhode Islanders who rely on SNAP benefits to purchase food for themselves and their families are forced to physically travel to grocery stores, increasing their risk of exposure to Covid-19; and

WHEREAS, In addition to facing health risks, many face other barriers such as not having the means to travel to grocery stores and facing limited food options at the stores due to increased demands for goods; and

WHEREAS, Rhode Islanders who rely on SNAP benefits are being forced to leave the safety of their homes in order to feed their families which may also be a large contributing factor to the disproportionate level of Covid-19 cases we are seeing in Rhode Island's communities of color; and

WHEREAS, Due to the social distancing and stay-at-home orders implemented in response to Covid-19, it is imperative that the federal government allow more states to implement the EBT Online Purchasing Program so that individuals reliant on SNAP are able to access food without increasing their risks of exposure to Covid-19.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council urges our federal partners to work with our state agencies to implement the EBT Online Purchasing Program in Rhode Island so that families who rely on SNAP can use their EBT cards to make online purchases and use delivery at accepted SNAP locations throughout the Covid-19 pandemic and beyond.

BE IT FURTHER RESOLVED, That, upon passage, copies of this resolution be sent to the Honorable Governor of the State of Rhode Island and to each member of Rhode Island's congressional delegation.

Resolution Requesting the City Council denounce Xenophobia and Anti-Asian sentiment.

WHEREAS, Hate crimes, discrimination, and aggression against Asian Americans are on the rise throughout the country largely due to xenophobic actors blaming Asian American ethnic groups for the COVID-19 outbreak; and

WHEREAS, Since the outbreak of the COVID-19 virus, more than 5,441,079 cases and more than 207,270 deaths have been confirmed worldwide as of April 27, 2020, according to the Johns Hopkins University Coronavirus Resource Center, and according to the Centers for Disease Control and Prevention, 928,619 cases and 52,459 deaths have been reported in the United States as of April 27, 2020; and

WHEREAS, Scientists have confirmed that the COVID-19 disease does not respect borders and is not caused by ethnicity; and

WHEREAS, The World Health Organization has cautioned against using geographic descriptors because such characterizations can fuel ethnic and racial discrimination; and

WHEREAS, According to 2019 estimates, approximately 6.1 percent of Providence's 179,335 residents are of Asian heritage; and

WHEREAS, As the COVID-19 virus has spread, Asian Americans have reported experiencing offensive comments and actions related to their race, racial profiling, hate incidents, and, in some cases, hate violence; and

WHEREAS, COVID-19 is a public health issue, not a racial one and characterizing COVID-19 as a "Chinese virus" only encourages hate crimes and incidents against Asian Americans at a time when communities should be working together to get through this crisis; and

WHEREAS, It is critical that the City take leadership and stand in solidarity with its Asian American communities to send a message that discriminatory and hate motivated behavior will not be tolerated; and

WHEREAS, All persons are encouraged to report any such xenophobic or discriminatory incidents to the proper authorities for investigation; and

WHEREAS, The City Council wishes to affirm its commitment to the well-being and safety of its Asian American community members and ensure they know they are not alone and that the City is committed to ending the spread of bigotry.

NOW, THEREFORE, BE IT RESOLVED, that the Providence City Council hereby denounces xenophobia and anti-Asian sentiment and joins cities, counties, and states across the country in affirming its commitment to the safety and well-being of Asian Americans and in combatting hate crimes targeting them.

Resolution Requesting an expansion to the notice requirements for Major Land Development Projects.

WHEREAS, The Department of Planning and City Plan Commission oversee the administration of the Providence Land Development and Subdivision regulations; and

WHEREAS, The Providence Land Development and Subdivision regulations categorize certain developments as Major Land Development projects; and

WHEREAS, Major Land Development projects undergo an extensive review process which includes multiple public hearings prior to any approval by the City Plan Commission; and

WHEREAS, Section 805 of the land development regulations only requires an applicant to provide written notice of the proposed development to property owners within 200 feet of the subject property; and

WHEREAS, Major Land Development projects have the potential to create substantial impacts to surrounding properties, businesses, and residences far beyond 200 feet from the property line.

NOW, THEREFORE, BE IT RESOLVED, that the Providence City Council hereby requests that the Department of Planning and the City Plan Commission revise Section 805 of the Land Development and Subdivision regulations to create an expanded notice provision for Major Land Development projects of at least 1,000 feet from the subject property.

BE IT FURTHER RESOLVED, That, upon passage, a copy of this resolution will be sent to the chairperson of the Providence City Plan Commission and the Director of the Providence Planning Department.

An Ordinance requiring the Department of Public Works to refund taxpayers who were incorrectly charged late removal fees for garbage receptacles.

COUNCILMAN SALVATORE Moves to Amend Section 2 by striking the word "thirty" and replacing it with "forty-five", also in Section 2 striking the number "30" and replacing it with the number "45" and in Section 3 striking the word "sixty" in line one and replacing it with the word "ninety" and the final amendment in Section 3 line one striking the number "60" and replacing it with the number "90", Seconded by COUNCILWOMAN HARRIS.
