That the following Minute on the Life and Character of the late Thomas J. King whose death occurred on March 21, 1960, is hereby adopted and ordered inscribed on the records of the City Council and a copy transmitted to the family of the deceased:

MINUTE

THOMAS J. KING was a life long resident of the Olneyville Section where he was born eighty-one years ago. His parents were the late Patrick and Bridget (McCormick) King. He was a member of the first graduation class of St. Teresa's School in which he manifested a life long interest. Following graduation from LaSalle Academy he took his college course at Manhattan College which recently honored him on the occasion of the 60th anniversary of his graduation.

He was the oldest practicing funeral director in the City having served the people in his area for more than sixty years. The high esteem in which he was held lead to his election to the Common Council from the old 10th Ward - now the 6th Ward. He was re-elected time after time and accumulated a continuous service record of sixteen years of dedicated public service. He was a founding member of the Manhattan Club of Rhode Island and for fifty years was a Trustee of St. Teresa's Church.

The members of this City Council hereby express their profound regret at the passing of such an exemplary citizen and public servant and extend condolences to his family in the hour of their bereavement.

of the City of Providence

Gentlemen:

I have been informed by Mr. Paul Connolly, Director of Public Relations for Providence College, that private subscriptions to defray the cost of telecasting the finals of the N.I.T. Basketball game have been approximately sufficient to meet the expenses involved.

I am most grateful to Providence College for their courtesy and cooperation in keeping us informed upon this matter. I think that you Gentlemen, like myself, would be pleased to approve the proposed six hundred (\$600) dollar appropriation as a means of facilitating presentation of this outstanding event to our local citizens. In view, however, of the fact that the needs of this fund have been substantially met otherwise, and that the College has indicated the proposed appropriation is not required I recommend that no further action be taken.
