Chapter 1644 of the Ordinances of the City of Providence as approved September 23, 1964 entitled: "An Ordinance Making Appropriation of \$46,159,931.36 for the Support of the City Government for the Fiscal Year Ending September 30, 1965", is hereby amended by appropriating the sum of One Thousand Five Hundred Fifty Four (\$1,554) Dollars to BUILDING INSPECTION ADMINISTRATION, ITEM 0.

SECTION 2. The said sum of One Thousand Five Hundred Fifty Four (\$1,554) Dollars as thus added and appropriated shall be charged to the General Fund from Funds Not Otherwise Appropriated.

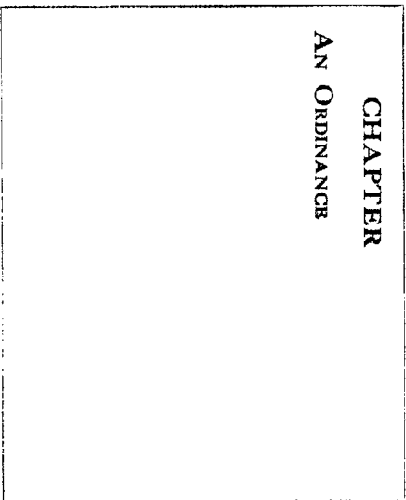

STORES REVOLVING FUND

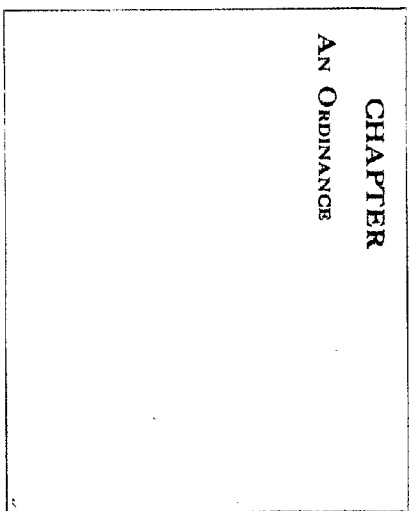
