No. 125

Approved March 16, 1990

WHEREAS, Rhode Islanders have worked for many years to conserve the environment to protect natural resources and the beauty of our state and its cities and towns;

adopting more environmentally sensitive lifestyles through actions such as recycling, conserving energy and water, and using efficient transportation;


using products least harmful to the environment and doing business with companies that are environmentally sensitive and responsible;


supporting legislation that helps protect the environment and voting for candidates who demonstrate an abiding concern for the environment;
