Our records as of this date show a total of 14.74 miles of City/~~Town~~ maintained road on the State Highway System in your City/~~Town~~, which under the provisions of the revised law, Chapter 28, Public Laws of 1959 which allots \$1,000.00 per mile for each mile of such unconstructed road, to a maximum of \$10,000.00 in any year, entitles your City/~~Town~~ to the sum of \$10,000.00 during the current year for this work.
