Be It Ordained By The City of Providence:

Section 1. The Zoning Map accompanying and made a part of Chapter 544 of the Ordinances of the City of Providence approved September 21, 1951, as heretofore amended and entitled: "An Ordinance Zoning the City of Providence and Establishing Use, Height and Area Regulations", is hereby further amended by changing from an R-4 Multiple Dwelling Zone to an M-1 General Industrial Zone, Lots 504 and 505, as set out and delineated on City Assessor's Plat 32, said lots being located along 336 Carpenter Street, and 166-170 Courtland Street, bounded and described as follows:

LOT 505

Beginning at a point on the easterly line of Courtland Street at the southwesterly corner of Lot 505 on City of Providence Assessor's Plat 32:

Thence running along the easterly line of Courtland Street to the northwesterly corner of Lot 505:

Thence easterly along the northerly line of herein described parcel to the northeasterly corner of Lot 505:

Thence southerly along the easterly line of Lot

505 to the southeasterly corner of herein described parcel:

Thence westerly along the southerly line of Lot 505 to the easterly street line of Courtland Street, said point being point and place of beginning.

Sec. 2. This Ordinance shall take effect upon its Passage.

An Ordinance in Amendment of Article IV of Chapter 14 of the Code of Ordinances of the City of Providence Relative to Off-Street Parking Structures.

Be It Ordained By The City of Providence:

Section 1. Article IV of Chapter 14 of the Code of Ordinances of the City of Providence is hereby amended by inclusion of the following:

Sec. 2. Any structure hereinafter constructed within the City of Providence, whether such structure be located above or under or upon the ground and used by the public for the parking of motor vehicles off the street or highway be exempt from taxation provided:

a.) That such structure increase by no less than two hundred percent (200%) the parking capacity of the premises as they existed prior to such construction.

b.) The owner(s) and/or operator(s) make(s) proper application for such exemption with the Assessor of Taxes upon a form and in a manner prescribed by him.

c.) That such application is approved by virtue of a resolution enacted by the City Council and approved by the Mayor.

d.) That any exemption from taxes shall be limited to that portion of the structure exclusively used for or devoted to the off-street parking of motor vehicles owned by the public.

e.) Should the structure cease to be used as parking facilities as described herein, within the period of said exemption, the owner and/or operator shall pay to the Collector of Taxes of the City of Providence any taxes together with any interest thereon at the regular rate and in the manner provided by law.

f.) No exemption shall extend beyond December 31, 1993.

g.) Any exemption shall become effective on the 31st day of December of the year in which said resolution is properly enacted; however, in no event shall any exemption be granted unless

application for the same is made prior to May 18, 1985.

Sec. 3. This Ordinance shall take effect upon its Passage.
