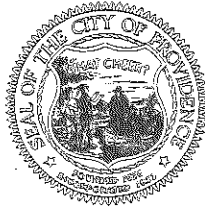





Dear Mr. Thomas:

The Datalux Tracer has several unique features that make it one of a kind in the field of police rugged mobile computers. Several of the Tracer features are patented or patent pending and can only be purchased from Datalux, making a computer like this unavailable anywhere else.

The Tracer All-in-One MDC is a fully integrated mobile data computer. The 12.1" display, Intel Core i5 CPU computer and vehicle conditioned power supply are integrated into a sealed single case. The thickness of the Tracer and our TRU-MOUNT mounting system (available only from Datalux) keeps the computer from interfering with airbag deployment. The ability of the airbags to fully deploy is a critical officer safety issue. It also takes up less space in the already crowded passenger compartment found in today's police vehicles.

A complaint by many officers using computers in police cars is that while typing reports they have to constantly twist and turn to the right to enter data into the computer. They have stated that this motion is a strain on their backs especially while wearing a gun belt and vest. Using our TRU-MOUNT universal mount, the Tracer is the only police MDC sold that has a removable keyboard that unclips from its center holder and mounts directly onto the steering wheel. If the officer gets a call for service all they have to do is place it back into the center holder using one hand, it is also backlit for nighttime use.

Since the Tracer is integrated into a one-piece unit it can be installed in a police vehicle in less than an hour. Our unique mounting and cabling system allows the computer to be installed without any modifications to the vehicle, dashboard or relocating the AM-FM radio. Once installed, any periodic maintenance to the system is quickly and easily performed. This feature allows the department to quickly return the vehicle back in service and reduce downtime.

If a wireless card is used as your mode of data transmission the Tracer is the only computer available that has a wireless card slot on top of the computer. This allows the Police Department to obtain the best reception possible without the use of an external antenna. Additionally, the aircard cover keeps the unit sealed.
