**No. 334 AN ORDINANCE** IN AMENDMENT OF AND IN ADDITION TO CHAPTER 1986-53 OF THE ORDINANCE OF THE CITY OF PROVIDENCE APPROVED OCTOBER 23, 1986 AND ENTITLED, "AN ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR THE SPECIAL VACANT LOT PROJECT" FOR THE ACQUISITION OF ADDITIONAL PROPERTIES.

### *Be it ordained by the City of Providence:*

1. That Chapter 1986-53 of the Ordinances of the City of Providence, approved October 23, 1986 and entitled, "An Ordinance Approving and Adopting the Official Redevelopment Plan for the Special Vacant Lot Project" as amended by the following: Chapter 1989-26, approved December 11, 1989 and Chapter 1997-3 is hereby further amended as follows:



583 CRANSTON ST.**





201 PAVILION AVE.**



**71-73 PEKIN ST.**


