RESOLUTION AUTHORIZING THE SUPERINTENDENT TO SEEK AN EXEMPTION FROM THE RESIDENCY REQUIREMENT OF THE CITY HOME RULE CHARTER THROUGH THE MAYOR FROM THE PROVIDENCE CITY COUNCIL

PRESENTED by Interim Superintendent Neil A. Corkery

WHEREAS, Certain vacancies in teaching positions have occurred as a result of the implementation of the Home Rule Charter of the City of Providence, Section 1210; and

WHEREAS, Concerted recruiting efforts have taken place from March 1989 to the present in an attempt to fill these vacancies; and

WHEREAS, A diligent search has determined that there are no qualified and certified applicants that are domiciled in the City of Providence or willing to sign an agreement that they shall become residents of the City within six (6) months of appointment; and

WHEREAS, it is essential that the teaching positions be filled;

NOW, THEREFORE, BE IT RESOLVED, That the Superintendent be authorized to request that the Mayor certify that after a diligent search no persons with proper qualifications can be found among residents of the City and that the City Council exempt the following teacher from the provisions of Section 1210 of the Providence Home Rule Charter:

Availability of other teachers:

Reading is an area that is very difficult to find certified teachers as a masters degree in Reading is required for certification. Celeste Bowler is currently three courses short of certification and is willing to complete any course work needed. Celeste lives in West Warwick and is unwilling to relocate as she has recently purchased a house in West Warwick. Mrs. Bowler is a minority candidate for this position.

Currently one vacancy still exist in Reading that the Personnel Office is trying to fill. \*

Elementary Spanish Bi-Lingual - Due to retirements and transfers 5 vacancies occurred in the Elementary Bi-Lingual area. This is also a very difficult certification area to fill Mr. Irizairy currently lives in East Providence and is unwilling to relocate. All other applicants were Providence residents and were hired.

Special Education - The most difficult area to fill 20 new hires have taken place since the close of school in June. The School Department is currently out-of-compliance and under state mandate to fill all positions with fully certified teachers.

Providence residents were given the first opportunities at full-time employment and were hired. Due to the large amount of vacancies hiring was needed from the outside the city to fill all vacancies.

School Nurse: 6 vacancies have occurred due to retirements. Donna Manion is a fully certified nurse who is Bi-Lingual (Spanish and Portuguese) and also deals with a large amount of Special Education students at Hope High School. Her expertise as a school nurse who is bi-lingual will be very beneficial to the Providence School Department.

The following outline highlights the efforts made by the Teacher Recruiter to fill the vacancies created by the early retirement incentive.

After the placement of 118 long term substitutes, there remained 70 vacancies.

The initial response to newspaper advertisements was favorable, however the residency requirement acted as a major deterrent for out-of-city applicants.

The greatest difficulty in the filling of vacancies occurred in the areas of Special Education, Reading Specialists, School Nurse Teacher, Spanish Bilingual Teachers in elementary and special education and special education elementary and secondary, School Librarians and Home Economics teachers.

We have not been successful in recruiting a sufficient number of Providence residents to meet our growing need. Even though a concerted effort has been made to recruit candidates from Providence, there are eight teachers that are requesting an exemption from the residency rule.

# Early retirement brings mass exodus from city schools

## 200 employees depart, including top administrators

PROVIDENCE — The state's early retirement incentive has done its job — perhaps too well.

Because of the incentive, 200 certified employees in the city schools, including the top 3 administrators, 5 principals and 179 teachers — nearly one-sixth of the entire teaching corps — have filed for retirement, causing an unprecedented number of key administrative and teaching vacancies that must be filled before schools open in two months.

"Never before in my memory have I seen this many people leave," said School Supt. Joseph Almagno, who was one of the biggest surprise retirees several weeks ago. "This is unbelievable."

In addition to Almagno, Deputy Supt. Mary O'Brien and Neil Corkery, the assistant superintendent for program and staff development, put in their retirement notices Friday, the last day for filing.

In fact, 140 people waited until the last day to file for retirement. Paul Vorro, the personnel director, said he went to the front reception area to gather the first retirement notices Friday morning and never left the area the rest of the day.

Many of the teaching jobs will be easily filled by promoting the system's extensive list of long-term substitutes to full-time status, but the mass exodus hits some areas hard.

And the loss of the top administrators, as well as 18 others, may be difficult for the system to absorb.

"To have the top three people leave at once, that's cause for some concern," Almagno said. "Superintendents are easy to come by. But finding individuals like Mary O'Brien and Neil Corkery to fill the deputy and assistant positions will be difficult. They represent the highest examples of accomplishment."

In addition to Mount Pleasant High School principal Charles Burke, who filed before Friday, principals James Dolan of Nathanael Greene Middle School, Judith Barrov of Camden Avenue Elementary

School, also is leaving, joining assistant principals at Hope High and Mount Pleasant High who had already filed.

Other top administrators who are retiring include Melvin Clanton, director of student services; Frank Piccirilli, language coordinator; Gordon Palumbo, information systems analyst; Richard Michael, educational technology director; Raymond Lamore, a principal assigned to central administration; Nicholas Lambros, coordinator of federal programs; and Sister Theresa Murtha, adult education supervisor.

### Supervisors to recruit

Among the teaching corps, 42 regular elementary, 22 guidance counselors, 15 English, 12 math and 10 social studies teachers will be leaving, in addition to smaller numbers in other areas.

Vorro said all area supervisors have been assigned to help in the recruiting process to fill vacancies. The location of the vacancies will not be known for several weeks, while administrators figure out which teachers who requested transfers can fill positions made by the retirees, and which spaces will not be covered by the long-term substitutes.

Most regular elementary, English, social studies, language, speech, music, business, physical education and guidance counselor positions should be filled from existing substitute lists, Vorro said.

New hires will be needed in math, science, art, special education, library and especially vocational education positions. The Central Vocational School was hit particularly hard — 11 of 21 staff members will be retiring, Vorro said.

School officials initially predicted that 30 of 100 eligible employees would take advantage of the city's retirement incentive, which required a minimum of 28 years of experience to qualify. The incentive included a pension bonus of \$150 for each year on the job, plus three years of dental and prescription drug coverage in retirement.

Then the General Assembly passed a sweeter deal — a 10 percent seniority bonus as a way of increasing pensions (a teacher or administrator with 30 years of ex-

fy. That created more eligible — and interested — school employees in the city.

The legislative retirement incentive applied to teachers in all Rhode Island communities. In Providence, the state incentive was in addition to the financial bonus the School Department was offering.

The retirement incentives are intended to help reduce the state and city budgets for this fiscal year. The saving comes by replacing retiring teachers at the top of the pay scale with newer teachers at the lower end of the pay scale.

Almagno said many of the retirees have been teachers with extensive experience and who often served leadership roles in their buildings. "That leadership will now have to be picked up by others," he said.

## Offer hard to refuse

For many teachers, the decision to retire was not easy. Vorro said many thought they had several more valuable years of teaching in them, but the financial picture made it difficult for them to turn down the retirement incentive.

He said some, not wanting to give up the classroom completely, have asked to substitute in a limited capacity.

Almagno said he will discuss the matter with the School Board, but does not plan to make appointments to fill the key administrative vacancies before he leaves at the end of the month.

"I don't think it's fair for me to appoint people to critical positions,"

he said. "I shouldn't be imposing my thoughts on my successor. He or she may have a totally different administrative style."

O'Brien, the No. 2 administrator for the last three years, started as an elementary teacher in the early 1960s and rose to the administrative ranks, making a significant impact as principal of Martin Luther King Elementary School in the late '60s.

She was responsible for implementing a systemwide reading program, introducing many early childhood intervention programs, and, in 1968, overseeing the implementation of the school system's desegregation plan in her district.

She served in several assistant superintendent positions before becoming deputy superintendent in 1986. "She is considered by many to be the most knowledgeable person in the system in all aspects of administration," Almagno said.

"There's no question she could have been the city's school superintendent if she had chosen to pursue it," he continued. "She has been an outstanding educational leader in the city."

Corkery, 49, a state representative from Warwick, started as a teacher at Nathanael Greene in 1968. He has been an assistant principal and then principal at several city schools, including Camden Avenue Elementary, and Greene from 1982-88.

He said he has no new job lined up yet, but would like to pursue the human services area, perhaps specializing in substance abuse. Statewide political office would be a possibility as well, he said.




