





AN ORDINANCE to allow the burning of cars at certain times by junk dealers and motor vehicle wreckers.

Approved

Be it ordained by the City of Providence:

Sec. 1. Junk Dealers - Any person holding both a junk shop license and a second-hand auto and parts license from the City of Providence and also a motor vehicle wrecker's license from the State of Rhode Island, may on the premises for which the license is granted and between the hours of 6 a.m. and 8 a.m. on Tuesday through Friday of each week, except on legal holidays, burn by means of open fire, motor vehicles and parts thereon for the purpose of disposing of combustibles thereon and therein.






