



RESOLUTION OF THE CITY COUNCIL

Former State Rep. William A. Babin Jr.

NARRAGANSETT — William A. Babin Jr., 64, of Ashton Lane, formerly of Biltmore Avenue, Providence, a former state representative and member of the state Board of Elections, died yesterday at Our Lady of Fatima Hospital, North Providence. He was the husband of Hope F. (Stearns) Babin.



Born in Providence, a son of the late William A. and Marie Elise (Gaudet) Babin, he lived in Narragansett nine years.

Mr. Babin was an independent agent for Nationwide Insurance Co. for 40 years.

He was a state representative from District 9 from 1967 to 1979. He was named a Deputy Majority Leader in 1969. Governor J. Joseph Garrahy appointed him a commissioner on the state Board of Elections in 1979; he served on that panel until 1991.

In his tenure as a state representative he was vice chairman of the House Corporations Committee, vice chairman of the Highway Safety Committee, vice chairman of the Governor's Justice Commission, a member of the Democratic Party Executive Committee, and a mem-

ber of the State Traffic Commission.

In 1962 he served on the Commission to Study Problems of Uninsured Drivers.

He was past Grand Knight of Dillon Council and a fourth degree Knights of Columbus of the Adams Assembly. He was past president of the Mount Pleasant Credit Union, was on the board of the directors of the Co-Op Credit Union, and was a member of the board of directors of RISDIC.

He was an usher at Blessed Sacrament Church and a member of the Holy Name Society. He was president of the Eastwood Look Association of Narragansett; past president of the Mount Pleasant Businessmen's Association and past president of the Mount Pleasant Lions Club.

Besides his wife he leaves two daughters, Susan L. Babin of Foster and Janice A. Lonardo of Providence; two sisters, Dorothy Herchen of Warwick and Ruth C. Babin of Cranston; and two grandsons.

His funeral will be held Monday at 8:45 a.m. from the J.F. Skeffington Chapel, 925 Chalkstone Ave., Providence, with a Mass of Christian Burial in the Church of the Blessed Sacrament, Academy Avenue, Providence, at 10. Burial will be in Gate of Heaven Cemetery, East Providence.
