Gentlemen:

Although I regard the proposed lease of the Gano Street Dump to Local 57 for purposes of an athletic field as a favorable opportunity for the City of Providence to acquire income from the property, and at the same time secure its useful development, I believe I have no alternative to vetoing the action taken in the June 5th meeting of the City Council authorizing the leasing of this property.

The necessity that I exercise the veto arises out of a technicality for which I am primarily responsible. The matter of sale of this property to Local 57 had come to my attention approximately a year ago. I had referred it informally to the City Plan staff for an opinion and was advised that the property should be kept in city ownership but that future plans for the area would in no way interfere with a lease agreement.

This opinion I reported to the City Property Committee at its recent meeting, but erroneously attributed the opinion to the Commission when as a matter of fact I now discover the Commission has not passed upon the matter at all. The City Property Committee accepting my assurance that the Commission had been consulted on this proposal previously, did not refer it this time to the Commission, but instead reported it directly to the City Council for the action which transpired last night. It appears essential, therefore, to correct this defect in procedure.

Having vetoed the action of the Council, I shall request the City Property Committee to again take the offer of Local 57 under advisement and to refer the proposal to lease to the City Plan Commission in proper accord with the requirements of law.

It is my expectation that this will be so scheduled that the City Council may again act upon the proposal at its meeting of July 3rd. In this manner, assuming the Council again regards the matter favorably, as I believe they should, leasing arrangements could be entered upon immediately thereafter.

I regret that this places a month's delay upon a desirable development but this appears necessary and inevitable.



His Honor the Mayor be and he hereby is authorized to execute a lease to the International Union of Operating Engineers, Local 57, of that certain area lying easterly of Gano Street, containing approximately 203,699 square feet of land and comprising Lot 566 on Assessor's Plat 14, and Lot 456 on Assessor's Plat 15; said lease to be for a period of twenty (20) years, with an option to renew for an additional period of twenty (20) years, the rental for the first twenty (20) years to be fifteen hundred (\$1500) dollars per annum. Said lease shall contain a recapture clause during the renewal period, and shall contain such other terms and conditions as may be approved by His Honor the Mayor and the City Solicitor.
