The Traffic Engineering Department has reviewed the following resolutions from your Committee and has taken the subsequent action:

✓ Request: That Claremont Street from Roanoke Street to Chalkstone Avenue be established as a one way street.

Disposition: No objection.

Request: That a 4-Way STOP control be established at the intersection of Princeton Avenue and Updike Street.

Disposition: The practice of establishing 4-way stop intersections is not recommended by this department. The right-of-way is not defined. I will conduct a new survey in a few months to see if there have been any changes in the traffic conditions.
