WHEREAS, Mr. Cardenas was a pillar of his community who impacted thousands of lives through his tireless work as a youth development advocate; and

WHEREAS, A native of Peru, Mr. Cardenas co-founded the Back to School Celebration of RI in 1999 with the goal of establishing an organization that would support parents involvement in the education of their children by creating an atmosphere of trust and open communication between schools, students, and families; and

WHEREAS, The Back to School Celebration of RI now provides 16,000 free backpacks and school supplies to students at twelve different sites throughout Rhode Island; and

WHEREAS, Mr. Cardenas was an initial national service pioneer in 1999 for the start up of AmeriCorps in Providence and he was instrumental in the development of Parents Making a Difference; and

WHEREAS, Mr. Cardenas excelled in community outreach efforts including youth development, workforce training, and career readiness initiatives, and he was a leader for social justice and community opportunity; and

WHEREAS, Through his work Mr. Cardenas forged a reputation as a true youth development advocate, team player, colleague, valued friend, and role model who was an active member in his community that was always involved in helping and supporting other individuals and organizations; and

WHEREAS, Jorge Cardenas was an outstanding community activist that made Rhode Island a better place by bringing together businesses, community leaders and elected officials to work for the well-being of children, and he has left a lasting impression on the thousands of lives he impacted within the City of Providence and the State of Rhode Island.





Resolution Regarding the Demographics of the Providence Police Department.

WHEREAS, The City of Providence is defined by its incredibly diverse population from many different races, ethnicities, nationalities, and backgrounds; and

WHEREAS, While the City's demographics demonstrate that minorities represent over 60% of the City's population, white police officers currently comprise over 67% of the entire Providence Police Department; and

WHEREAS, Aligning the demographics of a police department with the communities they serve helps to build trust and improves the dynamics between officers and local residents; and

WHEREAS, In the event of a future scheduled police academy, the Providence Police Department has a unique opportunity to take immediate action to address the disparity between its demographics and those of the City as a whole; and

WHEREAS, Although it will take time to fully realign the demographics of the Providence Police Department, the City can demonstrate a firm commitment to this process by committing to graduating the most diverse class of the new officers in the City's history.

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence hereby requests that the Mayor of Providence, the Public Safety Commissioner, and the Chief of Police commit to improving the diversity of the Providence Police Department, at all levels of the command structure, beginning with any forthcoming Police Academy graduating class and beyond.

BE IT FURTHER RESOLVED, That, upon passage, copies of this resolution be provided to the Mayor of Providence, the Commissioner of Public Safety, and the Chief of Police.

Resolution Recognizing International Transgender Day of Remembrance.

WHEREAS, Transgender is a term used to describe people whose gender identity differs from the sex they were assigned at birth; and

WHEREAS, Members of the queer, gender non-conforming, non-binary, and transgender community may describe themselves with various preferred pronouns; and

WHEREAS, In 1999, transgender advocate Gwendolyn Anne Smith arranged the first vigil and created the Transgender Day of Remembrance in honor of Rita Hester, a transgender woman of color who was murdered; and

WHEREAS, The 20th of November is marked to commemorate and memorialize individuals who have been murdered as a result of transphobia and is an internationally recognized annual event, with events held in 185 cities across 20 countries; and

WHEREAS, There are more than 2 million people who identify as transgender across the United States; and

WHEREAS, Transgender people face staggering levels of discrimination, stigma, and systemic inequality; and

WHEREAS, Transgender people, according to the "2015 U.S. Trans Survey: A Report by the National Center for Transgender Equality", 29% of transgender people live in poverty, 39% of Black trans adults, 48% of Latinx trans adults, and 35% of Alaska Native, Asian, Native Americans, and Native Hawaiian or Pacific Islander trans adults, compared to 14% of the general population; and

WHEREAS, Transgender people, particularly transgender women of color, face a lack of legal protection in housing, employment, and health care; and

WHEREAS, Transgender people and transgender Black Indigenous People of Color, face shockingly high rates of murder, poverty, homelessness, and incarceration; and

WHEREAS, Over 27 trans and gender non-conforming people have been violently killed in 2020 thus far; and

WHEREAS, Around the globe, there are countries who deplorably outlaw transgender people from living as their true authentic selves; and

WHEREAS, The City Council must act to protect, advocate for and preserve the lives of all constituents through inclusive legislation; and

WHEREAS, More progress needs to be made for the Providence and greater Rhode Island transgender community to address systemic inequities and enact nondiscrimination laws that demonstrate greater support for transgender equality and transgender elected official colleagues, in order to acknowledge, respect, and celebrate their wonderful contributions to society.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council

(1) recognizes, supports, and affirms the importance of Transgender Day of Remembrance;

(2) fly the trans flag at City Hall to honor members of the transgender community lost from transphobic violence

(3) commit to continuing to support and advocate for the trans community
