
Resolution approving the accompanying plat, entitled Dedication of Knowles Walkway, Mount Hope Renewal Project R. I., R-18, Providence Redevelopment Agency, Stanley P. Blacher, Chairman, et al, Scale 1" = 50.0' dedicating for walkway purposes certain tract or parcel of land, shown as a cross-hatched area and designated by the letters J-D-E-H and altering the shaded areas designated by the letters A-B-C-D-J-K and H-E-F-G from highway purpose to walkway purpose on the accompanying plan under the provisions of Chapter 987 of the Public Laws of 1913 and thereafter declared a public walkway to be repaired and maintained at the expense of the City of Providence.


