ORDINANCES SECOND READING

The following Ordinances were in City Council November 2, 1978, Read and Passed the First Time, and Are Returned for Passage the Second Time:

An Ordinance Amending the Appropriation Ordinance Chapter 1978-18, Approved July 28, 1978 by Increasing the Revenue Budget of the School Department in the Amount of Five Hundred Three Thousand, Five Hundred Fifty-Two Dollars (\$503,552.00).

Be it ordained by the City of Providence:

Section 1. Chapter 1978-18 of the Ordinances of the City of Providence, as approved July 28, 1978 and entitled "Making an Appropriation of One Hundred Fourteen Million, Nine Hundred Ninety-Eight Thousand, Eight Hundred Fifty Dollars, Ninety-Two Cents (\$114,998,850.92) for

the Support of the City Government for the Fiscal Year ending June 30, 1979," as amended, is hereby further amended by Increasing the Revenue Budget of the School Department in the amount of Five Hundred Three Thousand, Five Hundred Fifty-Two Dollars (\$503,552.00) as follows:

Sec. 2. This Ordinance shall take effect upon its passage.

An Ordinance in Amendment of and in Addition to Chapter 1977-5 of the Ordinances of the City of Providence, Approved February 14, 1977 and Entitled, "An Ordinance Approving and Adopting the Official Redevelopment Plan for Downtown Providence Renewal."

Be it ordained by the City of Providence:

1. That Chapter 1977-5 of the Ordinances of the City of Providence, approved February 14, 1977 and entitled, "An Ordinance Approving and Adopting the Official Redevelopment Plan for Downtown Providence Renewal" be and the same is hereby amended as follows:

A. Paragraph numbered 7 entitled, "Estimated Cost of Redevelopment and Proposed Method of Financing" as contained in and set forth in Page 23 of that certain booklet entitled, "Downtown Providence Renewal, Official Redevelopment Plan, 1976" which is a part of the aforementioned ordinance be and the same is hereby deleted and the following substituted therefor:

7. *Estimated Cost of Redevelopment and Proposed Method of Financing*

Line 1 \$500,000 — Acquisition and demolition of parking deck fronting Union Station.

Line 2 \$4,906,000 — Kennedy Plaza Capital Improvements.

Line 3 \$5,406,000 — Total Project Cost.

Line 4 \$3,925,000 — (80% of Line 2) UMTA (Urban Mass Transit Administration) financing of Kennedy Plaza Improvements.

Line 5 \$1,481,000 — (100% of Line 1 and 20% of Line 2) Total City Share.

B. Insert the following Paragraph 3 entitled, "Additional Renewal Plan Proposals" after Paragraph 2 entitled "Proposed Acquisition under Section E entitled "Renewal Plan Proposals" as contained in and set forth in Page 18 of that certain booklet entitled "Downtown Providence Renewal Official Redevelopment Plan, 1976" which is a part of the aforementioned ordinance.

3. *Additional Renewal Plan Proposals*

The proposed plan amendment integrates the Kennedy Plaza Transit Pedestrian Improvement Project capital elements into this Downtown Providence Renewal Plan. The plan consists of five major project element areas consisting of a connected network of exclusive busways, bus terminals, improved pedestrian connections and pedestrian plazas related to the bus terminals; and of auxiliary elements consisting of signing, information, and shelters at other downtown bus stops, traffic signals and pavement markings at key traffic intersections, directional signs for diverted traffic and for parking locations.

The five major project elements are: 1. Main Transit Terminals; 2. Dorrance Street Busway and Terminals; 3. Francis Street Busway; 4. Washington Street Bus Lane and Bus Stop; and 5. City Hall Plaza. (See Maps No. 4 and No. 5 "Site Improvements".)

C. Insert the following maps after Map No. 3 "Proposed Acquisition" of the aforementioned Official Redevelopment Plan, which is a part of the aforementioned ordinance.

- (1) Map No. 4 "Site Improvements" dated June 1978.
- (2) Map No. 5 "Site Improvements in Major Activity Area" dated June 1978.
- (3) Map No 6 "Right-of-Way Adjustments" dated June 1978.

2. That said Chapter 1977-5 of the Ordinance of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other respects.

3. That this Ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy thereof to the Providence Redevelopment Agency.
