

Dear Ms. Mendonca:

I notice in the City Council Journal of Proceedings that on December 1, 1977 the City Council directed its Committee on Public Welfare to investigate the recent annual pass fee increase request by the new leasees at Triggs Memorial Golf Course.

When this request was made at the November 15th meeting of the Board of Park Commissioners, action was deferred pending receipt of an opinion from the Acting City Solicitor on the Board's authority (if any) to extend the lease at lower city revenues without competitive bidding as requested by the new leasee. No opinion has been received as of this date. The next regular meeting of the Board is scheduled for January 10th; if the opinion is received by January 7th the Triggs fee increase request will be on the agenda of that meeting. Until and unless the Board of Park Commissioners agrees to a rate increase, the fees at Triggs remain unchanged. I hope this information will be helpful to you and to the Committee on Public Welfare.
