At this point COUNCILMAN BRADSHAW reads the following Editorial having appeared in the Providence Journal-Bulletin of October 15, 1977, entitled, "A Purchasing Plan That's Fair," and requests it be incorporated in the records of this meeting:

Because a bit of a bottleneck has developed with a new city purchasing system designed to avoid past abuses, some Providence officials now want to junk it and return to practices that proved unfair. Mayor Cianci properly is resisting

this while moving to speed up the procedures he installed last summer by executive order.

These basically apply to purchases of \$1,500 or less, not the bigger items handled under sealed bidding by the Board of Contract and Supply. Their smallness still doesn't excuse all suppliers not getting an even chance at the city business.

To curb favoritism charges that had been raised, the mayor required a minimum number of prices to be solicited and recorded by the purchasing office. Meanwhile, by consolidating departmental buying where feasible, this was to be subjected to the sealed bid process for major purchases. A loophole was left for emergency situations.

It is a system that will prove equitable once the kinks causing a slowdown are worked out. The main shortcoming seems to be lack of people to handle the increased paperwork; the purchasing office was among those reduced by budgetary personnel cutbacks. Mr. Cianci plans to provide relief by assigning two employees there from the federal Comprehensive Employment and Training Act (CETA) program.

This should help to uncork the bottled up purchase orders and that should still the criticism. At the same time, there should no longer be complaints that anyone has an unfair advantage in contracting with the city. Achieving that is worth whatever temporary difficulty is being encountered as long as it is quickly overcome.
