Resolution confirming and approving Settlement of Two E.P.A. Federal Cases entitled United States vs. City of Providence.

Whereas, On or about May 4, 1978, the City entered into Consent Decrees with the United States in C.A. No. 77-0374(B) and 77-0375(P); and

Whereas, The said decrees provided civil penalties in the sum of \$2,500.00 per day of violation by the City of certain guidelines in the operation of the City's sewage treatment plant and incinerator; and

Whereas, The City had previously been found in contempt of the decrees in UNITED STATES vs. CITY OF PROVIDENCE, 492 F. Supp. 602 (1980); and

Whereas, On December 30, 1983, by court judgment (J. Pettine) a fine of \$622,500 was imposed in C.A. No. 77-0375(P); and

Whereas, A motion is pending to impose a fine of \$822,500 in the companion case no. 77-0374(B) scheduled in Federal Court on June 8, 1984, and a Judgment for said amount will most probably be entered; and

Whereas, The total liability of the two cases against the City will total \$1.44 million dollars; and

Whereas, The parties have entered into extended negotiations for settlement; and

Whereas, His Honor the Mayor in consultation

with the Law Department and the Finance Director has negotiated and approved a settlement of the said cases, in the aggregate sum of \$430,000, payable as follows: F.Y. 84-85: \$150,000; F.Y. 85-86: \$150,000; F.Y. 86-87: \$130,000; and

Whereas, This settlement reduces the liability of the City by over 1 million dollars; and

Whereas, It is in the best interest of the City to conclude these cases and enter into the said settlement, in the form of the stipulation attached hereto.

Now Therefore be it Resolved, His Honor the Mayor, and the City Solicitor are hereby authorized and empowered to enter into and execute such documents, as would effect the said settlement, and that such settlement is hereby ratified, confirmed and approved.

COUNCILWOMAN CAROLYN F. BRASSIL, Chairwoman COMMITTEE ON FINANCE

An Ordinance Establishing a City of Providence Contract Negotiating Board.

It is the intention of the City Council and it is hereby ordained that the provisions of this Ordinance shall become and be made part of the Code of Ordinances of the City of Providence,

Rhode Island, and the Sections of this Ordinance may be renumbered to accomplish such intention.

Be it ordained by the City of Providence:

Section 1. There is hereby established a City of Providence Contract Negotiating Board which

shall comprise of the Mayor, or his designee, the Finance Director, the Personnel Director, the Chairperson of the Committee on Finance of the City Council or designee and the City Council President, or designee, who is a Member of the City Council; the non-voting member shall be the City Solicitor.

Sec. 2. This Board shall negotiate all contracts with any and all labor unions which would involve wages, hours and conditions of employment by and between the City of Providence and the respective labor unions.

Sec. 3. This Ordinance shall take effect upon its Passage and all Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

Read and Passed the Second Time, on motion of COUNCILWOMAN FARGNOLI, seconded by COUNCILMAN ANNALDO, by the following Roll Call Vote:

An Ordinance in Amendment of Chapter 17 of the Code of Ordinances of the City of Providence, entitled: "Officers and Employees". (Cooperation with Law Enforcement Agencies.)

Be it ordained by the City of Providence:

Section 1. Chapter 17 of the Code of Ordinances of the City of Providence, entitled "Officers and Employees" is amended by adding thereto Section 17-32, entitled "Cooperation with Law Enforcement Agencies" which shall read as follows:

"Section 17-32. *Cooperation with Law Enforcement Agencies.* No officer or employee of the City of Providence shall in any way discriminate against or take adverse action against any other officer or employee of the City of Providence solely on account of the latter's cooperation with or assistance to any federal, state or local law enforcement agency in connection with any matters affecting the City of Providence, any investigation thereof or any proceedings arising therefrom. If any officer or employee of the City of Providence violates this section of the Code of Ordinances, he or she shall be guilty of an offense punishable pursuant to Section 1-10 of this Code of Ordinances."

Sec. 2. This Ordinance shall take effect upon its passage.

Read and Passed a Second Time, on motion of COUNCILMAN GLAVIN, seconded by COUNCILWOMAN FARGNOLI, by the following Roll Call Vote:

An Ordinance in Amendment of Chapter 21 of the Code of Ordinances of the City of Providence, entitled: "Revenue and Finance". (Qualifications of parties doing business with the City.)

Be it ordained by the City of Providence:

Section 1. Chapter 21 of the Code of Ordinances of the City of Providence entitled "Revenue and Finance" is hereby amended by adding thereto the following:

"Section 21-28 (a). *Qualifications of parties doing business with the City of Providence.*

(a) In awarding bids for purchase of materials or services by the City of Providence, the Board of Contract and Supply and the Purchasing Department of the City of Providence shall take into consideration, among other factors, the background and reputation for honesty and integrity of the parties who have bid on the particular materials or services. In order to assist the Board of Contract and Supply and other departments of the City of Providence in considering the foregoing, the Mayor, the Finance Director of the City of Providence or the Chairperson of the Finance Committee of the City Council of the City of Providence may request the Chief of the Providence Police Department to conduct a background check on any party bidding or submitting bids for sale of services or materials to the City of Providence and/or any owner, officer or director of any such party. Upon receipt of any such request, the Chief of Police shall conduct such an investigation including, without limitation, to determine whether any such bidding party or any officer, director or owner thereof has been convicted of any criminal offense and shall report his findings to the party requesting such information and to the Board of Contract and Supply.

(b) The results of any such investigations shall be public records of the City of Providence."

Sec. 2. This Ordinance shall take effect upon its passage.

COUNCILMAN GLAVIN moves that the Ordinance be amended by deleting in Subsection (a), Line 9, following the word "foregoing", "any member of the Board of Contract and Supply, the Finance Director of the City of Providence or the Finance Committee of the City Council of the City of Providence" and insert in lieu thereof: "The Mayor, The Finance Director of the City of Providence or the Chairperson of the Finance Committee of the City Council of the City of Providence".

Be it ordained by the City of Providence:

Section 1. Chapter 21 of the Code of Ordinances of the City of Providence entitled, "Revenue and Finance" is hereby amended by adding Article II thereof the following:

"Section 21-38(A). *Mailing of Checks to Vendors.* All parties providing materials and/or services to the City of Providence who are entitled to payment of money by the City of Providence on account thereof shall receive all such payments by United States mail, proper postage prepaid, addressed to their respective business addresses on file with the City of Providence."

Sec. 2. This Ordinance shall take effect upon its Passage.

An Ordinance in Amendment of Chapter 17 of the Code of Ordinances of the City of Providence, entitled: "Officers and Employees", as Amended. (Mailing of Paychecks.)

Be it ordained by the City of Providence:

Section 1. Chapter 17 of the Code of Ordinances of the City of Providence entitled: "Officers and Employees" is hereby amended by adding to Article I thereof the following:

"Section 17-31. *Mailing of Paychecks.* At least three times during each fiscal year of the City of Providence commencing with the fiscal year ending June 30, 1985 all employees and officers of the City of Providence shall receive their weekly paychecks by United States mail, proper postage prepaid, addressed to their respective residence

addresses on file with the City of Providence. At least once each fiscal year of the City of Providence, all officers and employees of the City of Providence receiving pay on a monthly basis shall receive said paychecks by United States mail, proper postage prepaid, addressed to their respective residence addresses on file with the City of Providence.

2. The Finance Director shall select in his discretion the weekly or monthly paychecks to be provided to employees by United States mail without prior public notice to employees."

Sec. 2. This Ordinance shall take effect upon its Passage.

(a) Each existing employee of the City of Providence, shall, within 30 days after the effective date of this ordinance and each person hereafter entering into employment with the City of Providence shall, at the time of filing an application for employment with the City of Providence, execute and deliver to the personnel director of the City of Providence a certified statement setting forth true and complete answers to the following questions:

1. Have you ever been convicted of an offense or been fined, or received a suspended or deferred sentence or been placed on probation, under the laws of the United States of America, any state of the United States of America and/or any county, municipal or other jurisdiction within the United States of America other than a parking violation or a moving vehicle violation which is not a felony?

1.1 If so, list the following for each conviction, approximate date of conviction, court of conviction, offense of which convicted and sentence.

(b) Any employee of the City of Providence shall, within 15 days after any change in circumstances which renders said employee's existing sworn statement under Section 17-30 (a) incorrect or incomplete in any respect, file an amended certified statement setting forth the correct and complete information with the personnel director of the City of Providence.

(c) Any employee who fails to file and maintain on file an accurate certified statement required by Sections 17-30 (a) and (b) and any employee who files a certified statement required by Section 17-30 (a) and (b) which is inaccurate or incomplete in any respect shall be subject to disciplinary action, including without limitation termination of employment and all benefits associated therewith.

(d) The filing of a certified statement required

by Section 17-30 (a) or (b) which is incomplete or inaccurate in any respect shall be deemed a violation of the Code of Ordinances of the City of Providence punishable as set forth in Section 1-10 of the Code of Ordinances of the City of Providence.

(e) The personnel director of the City of Providence shall, upon the effective date of this ordinance, prepare a form of certified statement consistent herewith and shall thereupon and from time to time thereafter provide such statement to each existing and new employee of the City of Providence and shall maintain all such sworn statements on file. All such certified statements shall be public record of the City of Providence.

(f) No employee shall be adversely affected in the terms and conditions of his or her employment solely on account of filing or maintaining an accurate certified statement under Section 17-30 (a) and (b).
