## ORDINANCES SECOND READING

The following Ordinances were in City Council May 2, 1996, Read and Passed the First Time and are returned for Passage the Second Time:

An Ordinance amending Chapter 20 of the Ordinances of the City of Providence entitled: "Redevelopment Areas" as amended.

*Be it ordained by the City of Providence:*

1. That Sections 20-1 through 20-20 of Chapter 20-20 entitled, "Redevelopment Areas" is hereby eliminated and the following five (5) Sections will be added in their stead:

*Section 1. Authority; designation of areas.*

The City Council of the City of Providence hereby designates, in accordance with R. I. G. L. 45-32-4, the redevelopment areas as set forth in this Chapter.

*Section 20-2. Area 1.*

The following area in the City of Providence shall be designated as Area-1:

Beginning at a point at the centerline intersection of Interstate Route 146 and the North Providence Town Line;

Thence turning and running southerly along Interstate Route 146 to its intersection with Interstate Route 95;

Thence turning and running southerly along Interstate Route 95 to its intersection with Interstate Route 6;

Thence turning and running westerly along Interstate Route 6 to its intersection with the Johnston Town Line;

Thence turning and running northerly along the Johnston Town Line and Providence City Line to its intersection with the North Providence Town Line;

Thence turning and running along the City Line and the North Providence Town Line to its intersection with Ferncrest Blvd and the westerly boundary of Rhode Island College;

Thence turning and running southwesterly along the westerly boundary line of the Rhode Island College approximately 1,230 feet to the intersection of the westerly boundary line of the State Home and school and the northerly Boundary of Triggs Memorial Park;

Thence turning and running southwesterly across Triggs Memorial Park approximately 1,440 feet to the intersection of the westerly boundary of Triggs Park and Bullock Avenue on range of the southerly side of Batterson Street;

Thence southerly and easterly along the Triggs Park boundary approximately 2,230 feet to the intersection of the park boundary and Chalkstone Avenue;

Thence in a generally easterly direction along the northerly side of Chalkstone Avenue approximately 2,492 feet to the intersection of Chalkstone Avenue and the easterly boundary of Triggs Park;

Thence in a generally northeasterly direction along the Triggs Park boundary approximately 2,522 feet to the intersection of the easterly boundary of Triggs Park with the southerly boundary of the Mt. Pleasant High School property;

Thence easterly along the southerly boundary of Mt. Pleasant High School approximately 1,325 feet to the westerly side of Mt. Pleasant Avenue;

Thence southerly along the westerly side of Mt. Pleasant Avenue to its intersection with Canonchet Street;

Thence westerly along the westerly side of Canonchet Street to its intersection with Winthrop Avenue;

Thence southerly along the westerly side of Winthrop Avenue to its intersection with the southerly side of Chalkstone Avenue;

Thence westerly along the southerly side of Chalkstone Avenue to its intersection with Leah Street;

Thence southerly along the westerly side of Leah Street to its intersection with the southerly side of Atwells Avenue;

Thence easterly along the southerly side of Atwells Avenue to its intersection with the easterly side of Academy Avenue;

Thence northerly along the easterly side of Academy Avenue to its intersection with the southerly side of Newark Street;

Thence easterly along the southerly side of Newark Street to its intersection with the easterly side Cutler Street;

Thence northerly along the easterly side of Cutler Street to its intersection with the southerly side of Cliff Street;

Thence easterly along the southerly side of Cliff Street to its intersection with the easterly side of Allston Street;

Thence easterly along the southerly side of Allston Street to its intersection with the westerly side of Wolcott Street;

Thence southerly along the westerly side of Wolcott Street to the rear lot line of Lot 437 on A. P. 66;

Thence easterly along the northerly lot line of Lot 437 to the easterly lot line of Lot 437;

Thence southerly along the easterly lot line of Lot 437 to its intersection with the northerly lot line of Lot 216 on A. P. 66;

Thence easterly along the northerly lot line of Lots 216, 217, and 220 on A. P. 66;

Thence southerly along the easterly lot line of Lot 220 to its intersection with the northerly side of Valley Street;

Thence easterly along the northerly side of Valley Street to its intersection with the westerly side of Raymond Street;

Thence northerly along the westerly side of Raymond Street to its intersection with the southerly side of Smith Street;

Thence westerly along the southerly side of Smith Street to its intersection with the westerly side of Huxley Avenue;

Thence northerly along the westerly side of Huxley Avenue to its intersection with the southerly side of Admiral Street;

Thence westerly along the southerly side of Admiral Street to its intersection with the westerly side of Sharon Street;

Thence southerly along the westerly side of Sharon Street to its intersection with the northerly side of Naples Avenue;

Thence southerly along the northerly side of Naples Avenue to the easterly intersection with Enfield Avenue;

Thence northerly along the easterly side of

Enfield Avenue to its intersection with the southerly side of Isabella Avenue;

Thence westerly along the southerly side of Isabella Avenue to its intersection with the easterly side of Longwood Avenue;

Thence southerly along the easterly side of Longwood Avenue to its intersection with the northerly side of Smith Street;

Thence southerly along the northerly side of Smith Street to its intersection with the southwesterly side of Cathedral Avenue;

Thence southerly along the southwest side of Cathedral Avenue to its intersection with the easterly side of Mt. Pleasant Avenue;

Thence northerly along the easterly side of Mt. Pleasant Avenue to its intersection with the North Providence Town Line;

Thence northerly along the North Providence Town Line to the point and place of beginning.

*Section 20-3. Area 2.*

Beginning at a point of the centerline of Interstate Route 146 and its intersection with the North Providence Town Line;

Thence turning and running in a southerly direction along Interstate Route 146 to its intersection with Interstate Route 95;

Thence and running in a northerly direction along Interstate Route 95 to its intersection with the southerly side of Industrial Drive;

Thence turning and running in a easterly direction along the southerly side of Industrial Drive to its intersection with the westerly side of North Main Street;

Thence turning and running in a southerly direction along the westerly side of North Main Street to the intersection with the westerly side of Canal St.

Thence turning and running southeasterly along Canal Street to the point where Canal Street becomes South Water Street;

Thence turning and running in a southeasterly direction to the southeasterly intersection of Crawford Street and South Water Street;

Thence turning and running southeasterly along the southeasterly side of Crawford Street approximately 55 feet to the southeasterly intersection of the Crawford Street Bridge and the harbor line;

Thence turning and running along said harbor lines of the Providence River and Seekonk River to its intersection with the New York, New Haven and Hartford Railroad right-of-way;

Thence in a generally northwesterly direction approximately 1,200 feet to its intersection with the westerly side of Gano Street;

Thence northerly along the westerly side of Gano Street to its intersection with the southerly side of East George Street;

Thence westerly along the southerly side of East George Street to its intersection with the easterly side of Governor Street;

Thence southerly along the easterly side of Governor Street to its intersection with the southerly side of Power Street;

Thence westerly along the southerly side of Power Street to its intersection with the easterly side of Thayer Street;

Thence southerly along the easterly side of Thayer Street to its intersection with the southerly side of John Street;

Thence westerly along the southerly side of John Street to its intersection with the westerly side of Benefit Street;

Thence northerly along the westerly side of

Benefit Street to its intersection with the southerly side of Angell Street;

Thence easterly along the southerly side of Angell Street to its intersection with the easterly side of DeFoe Place;

Thence northerly along the westerly side of the extended easterly side of DeFoe Place to its intersection with southerly side of Meeting Street;

Thence westerly along the southerly side of Meeting Street to its intersection with the easterly side of Congdon Street;

Thence northerly along the easterly side of Congdon Street to its intersection with the southerly side of Halsey Street;

Thence easterly along the southerly side of Halsey Street to its intersection with the westerly side of Brown Street;

Thence northerly along the westerly side of Brown Street to its intersection with the southerly side of Olney Street;

Thence easterly along the southerly side of Olney Street to its intersection with the westerly side of Hope Street;

Thence northerly along the westerly side of Hope Street to its intersection with the southerly side of Doyle Avenue;

Thence westerly along the southerly side of Doyle Avenue to its intersection with the westerly side of Camp Street;

Thence northerly along the westerly side of Camp Street to its intersection with the southerly side of Rochambeau Avenue;

Thence westerly along the southerly side of Rochambeau Avenue to its intersection with the westerly side of North Main Street;

Thence northerly along the westerly side of

North Main Street to its intersection with easterly side of Cemetery Street;

Thence northerly along the easterly side of Cemetery Street to its intersection with the westerly side of Nashua Street;

Thence northerly along the westerly side of Nashua Street to its intersection with the city line;

Thence turning and running in a westerly direction along the city line to the point and place of beginning.

#### Section 20-4. Area 3.

Beginning at the southwesterly intersection of Interstate Route 146 and Interstate Route 95;

Thence turning and running along Interstate Route 95 in a southerly direction to a point opposite the westerly side of Henderson Street;

Thence turning and running easterly along the southerly side of Henderson Street to its termination at the harbor line;

Thence turning and running northerly along the harbor line to its southwesterly intersection with the Crawford Street Bridge;

Thence turning and running northeasterly along the southeasterly side of Crawford Street to its intersection with South Water Street;

Thence turning and running northerly along South Water Street to the point where South Water Street becomes Canal Street;

Thence turning and running northerly along Canal Street to its intersection with the westerly side of North Main Street;

Thence turning and running northerly along the westerly side of North Main Street to its intersection with the southerly side of Industrial Drive;

Thence turning and running westerly a long the southerly side of Industrial Drive to its intersection with Interstate Route 95;

Thence turning and running southerly a long Interstate Route 95 to the point and place of beginning.

*Section 20-4. Area 4.*

Beginning at the intersection of the centerlines of the Town of Johnston and the Woonasquatucket River;

Thence turning and running westerly along the Johnston Town Line and the Providence City Line;

Thence turning and running southerly along the Providence City Line and the Johnston Town Line to its intersection with Sunset Avenue;

Thence turning and running southeasterly along the southerly side of Sunset Avenue to its intersection with Killingly Street;

Thence turning and running southeasterly along the southerly side of Killingly Street to its intersection with Duxbury Street;

Thence turning and running southerly along the westerly side of Duxbury Street to its intersection with Plainfield Street;

Thence turning and running southerly along the westerly side of Plainfield Street to its intersection with the Cranston City Line;

Thence turning and running easterly along the Cranston and Providence City Line;

Thence turning and running along the Cranston and Providence City Line to its intersection with the Harbor Line;

Thence turning and running northerly a long the Harbor Line to its intersection with Henderson Street;

Thence turning and running westerly along the southerly side of Henderson Street to its intersection with Interstate Route 95;

Thence turning and running northerly along Interstate Route 95 to its intersection with Interstate Route 6;

Thence turning and running westerly along Interstate Route 6 to its intersection with the Woonasquatucket River;

Thence turning and running northerly along the Woonasquatucket River to the point and place of beginning.

An Ordinance approving and adopting the Official Redevelopment Plan and the attached restrictions for the Douglas Avenue Revitalization Project.

*Be it ordained by the City of Providence:*

*Whereas*, The Providence Redevelopment Agency (PRA), pursuant to the provisions of the Rhode Island General Laws (RIGL) Title 45, Ch. 32, as amended, has formulated a plan entitled "The Douglas Avenue Redevelopment Project," (Redevelopment Plan) attached and made part of this Ordinance; and

*Whereas*, *Providence 2000, The Comprehensive Plan* has been prepared and adopted by the City Plan Commission and the City Council pursuant to RIGL Section 45-22.2 et. seq., and is recognized and used as a guide for the general development of the City of Providence as a whole; and

*Whereas*, The said Redevelopment Plan's Project Boundary encompasses an area which has been designated "Redevelopment Areas" by the City Code of Ordinances, Chapter 20, as amended; and

*Whereas*, The City Plan Commission, which is

the duly designated and acting official planning body for the City, has submitted to the City Council its report and recommendations respecting the Douglas Avenue Redevelopment Plan and has certified that said Redevelopment Plan conforms to the said Comprehensive Plan for the City as a whole, and the City Council has duly considered said report, recommendations and certification of the planning body; and

*Whereas*, A structural quality survey, conducted by the City of Providence, Department of Planning and Development, indicated that a number of the structures have deficiencies that included serious deterioration. The Douglas Avenue Revitalization Project Area is not restricted to, nor does it consist entirely of lands, buildings, or improvements which of themselves are detrimental, but is an area in which such conditions exist and injuriously affect the entire area.

*Now, therefore, be it ordained by the City of Providence:*

1. The Project is hereby designated as "The Douglas Avenue Revitalization Project." The Project Area will be designated number 35.

2. It is found and declared that the Douglas Avenue Redevelopment Plan Area contains blighted and substandard properties, some of which require demolition and clearance while others require rehabilitation and improvement. These include:

A. *Defective or Inadequate Street and/or Lot Layout.* The intersection of Eaton Street and Douglas Avenue is poorly laid out and in need of redesign. There are also building lots which were platted at a time when open space was not a concern. When possible, it is important to expand the size of the building lots through merging with adjacent properties, while insuring that the dense character of the housing in the neighborhood is not lost.

B. *Incompatible Uses.* Douglas Avenue was intended to serve as a commercial corridor for

the Smith Hill neighborhood of Providence. It was also lined with relatively high density residential uses. Both the vacant lots and vacant buildings are a blighting influence on the neighborhood and do not support the intended use.

C. *Obsolete or Aged Buildings, Not Suitable for Improvement for Conversion.* While there are a number of older buildings which have been well maintained over the years, there are also structures which are both aged and in dilapidated condition. Some of these, where the cost rehabilitation is prohibitive, must be removed.

D. *Inadequate Provision for Ventilation, Light, Sanitation, Open Space and Recreation Facilities.* There is a lack of public open space and recreational facilities on Douglas Avenue itself. The vacant lots do have sanitation problems which would be solved through new investment.

E. *Defective Design or Unsanitary or Unsafe Character or Condition of Physical Construction.* The vacant buildings help create an unsafe character in parts of Douglas Avenue.

3. It is the intent of the City Council to use powers granted under RIGL 45-32-1 et seq, as amended, to acquire vacant and/or blighted properties, reduce density of housing, facilitate rehabilitation of deteriorated structures, provide site improvements, and provide for the orderly redevelopment of the project area.

4. It is found and declared, pursuant to RIGL 45-32-20, that:

A. The Douglas Avenue Redevelopment Plan Area is feasible, conforms to the Comprehensive Plan, and if carried out, will promote the public health, safety, morals and welfare of the City of Providence.

C. The acquisition of the real property in accordance with the Douglas Avenue Redevelopment Plan Area is in the public interest.



D. The Redevelopment Plan shall provide for payment of property which may be acquired by the exercise of eminent domain has been made in the Redevelopment Plan.

E. The Redevelopment Plan contains adequate safeguards to assure the carrying out of the work of redevelopment.

F. The Redevelopment Plan provides for the retention of controls and the establishment of restrictions and covenants which may run the land.

5. The Douglas Avenue Revitalization Project, is hereby approved, adopted and designated as the Official Redevelopment Plan for the Douglas Avenue Revitalization Project Area and is herein incorporated by reference, made a part hereof and designated as "Exhibit A".

6. In order to implement and facilitate the effectuation of the Redevelopment Plan hereby approved, the City Council declares:

A. That it will provide the cost of the redevelopment of the Redevelopment Project Area, and hereby allocates \$125,000.00 representing the estimated amount of the Project Cost;

B. That the PRA and hereby is authorized and directed to utilize from time to time, in such sums as may be necessary, not exceeding One Hundred Twenty Five Thousand (\$125,000.00) Dollars and to disburse that the amount from the City's Community Development Block Grant (CDBG) for Program Year 21. The money thus obtained shall be used from exclusively for carrying out the Official Redevelopment Plan for the Douglas Avenue Revitalization Project. Future funding may be allocated from succeeding years of the CDBG Program, as available.

C. That the street layout deficiency at the intersection Douglas Avenue and Eaton Street be remedied, if funds are available.

D. That payment for property to be condemned is permitted.

E. That the Community Development Block Grant (CDBG) funds are available to effectuate said Douglas Avenue Revitalization Project.

F. That the controls contained within the Redevelopment Plan shall follow the Zoning Ordinance of the City of Providence, as amended.

7. This ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy of this Ordinance to the Providence Redevelopment Agency.

An Ordinance amending the City of Providence Zoning Ordinance Chapter 1994-24, No. 365, approved June 27, 1994 and amended May 26, 1995.

*Be it ordained by the City of Providence:*

Section 1. Chapter 1994-24, No. 365, approved June 27, 1994, and amended May 26, 1995, shall be amended as follows:

Section 103 — *Official Zoning Map*, by changing the zoning designation on Providence Zoning District Map 100, Portion of Lot 2, and described as a rectangular parcel beginning at a point on the northeastern corner of Lot 499 on Assessor's Plat 76, and running approximately 117 feet southeasterly along the State of Rhode Island Highway Line (Route 146), thence turning approximately 112° along a line parallel to Clarksen Street and running 306.3 feet, thence turning 90° and running in a northerly direction 109.25 feet to the southeastern corner of said Lot 499 on Assessor's Plat 76, thence running along the eastern boundary of said Lot 499 on Assessor's Plat 76, 348.63 feet to the beginning point, from OS Open Space District to M-1 Industrial District.

Section 2. This Ordinance shall take effect upon its passage.

## PERSONAL EXPRESSION

**COUNCILMAN IGLIOZZI requests the privilege of the floor to speak on a point of Personal Expression and states:**

"In response the School Committee's request, I don't know if everybody has that, it should be in your manila envelope. I am going to direct that

the clerk photocopy this and present this to every single Council person, but I want to make some brief comments about this and just so that people are aware of what happened at the Ethics Commission. As you may or may not be aware the School Board filed an advisory request that asked for an advisory opinion, the State of Rhode



Island regarding their ability to vote on school contracts with the teachers, because as a matter of practice they normally receive the same benefit package, i.e., Blue Cross, Retirement, etc., as the teachers. Their first meeting at the Ethics Commission, certain questions were raised, and I think Councilman Lombardi indicated to me that there were questions raised why the President of the City Council did not appear, and what the City Council's position was on that. I took it upon myself and contact the City Solicitor's office and ask him to take time out of his busy schedule, and I want to publicly thank Charles Mansolillo for doing so. It's certainly beyond the scope of his authority, or the scope of his duties, but he did so at my request. We appeared at the Ethics Commission, and the question at that time, I did testify before the Ethics Commission, they were very concerned because there are no minutes to suggest how we pass and approve the School Board budget separate and apart from the school contracts. I had indicated at that meeting that we in fact passed an Ordinance that changed the entire City employee's staff to City Blue, and even if the teacher's or the firemen, or the policemen were to change back to the original Blue Cross plan by way of arbitration and negotiation, that would not have any impact on any non union employee, or impact on any board member, any agency. Once you pass an Ordinance on an agency or board member, they are not in the union so obviously if we say everybody is going to be on City Blue and the school teachers get an arbitrator to say otherwise, not arbitrator, a court decision or a negotiator decision to say otherwise, that wouldn't affect the Board members. The reason why I raise that point is they went out of their way to indicate that they should be the separate analysis between approving school contracts by the council and approving School Board member's benefit packages. Even though we did so by Ordinance, it's going to be my request, at the City Solicitor's request, that we now indicate in that Ordinance that we designate and separate appointees, Board members, agency binding, I mean labor contracts. That we would not have a problem like we had here. The bottom line is the City Council didn't have the question,

the School separate analysis by the City Council. As a fact of the matter, we do give a separate analysis by passing that Ordinance, but as a practical matter, we don't make a distinction between employee, appointee or agency. I raise that so that everybody is aware of it. It was an interesting discussion. I don't know if the City Solicitor has anything to add, and I'm not so sure that I explained it that clearly, but I did want everybody to be aware that that issue came up at the Ethics Commission, and I think we should be very sensitive to those kinds of issues in the future. Again, it wasn't at our request, nor was the City Council called on the carpet or anything like that. It wasn't that at all. They wanted to know what the City Council's position was, and while I am not speaking for the City Council, I did present to them an approved Ordinance, passed by the majority of the City Council, in fact a unanimous City Council, changing City Blue for all employees. So I could not speak for the City Council regarding that Ordinance. We all spoke on that, whatever date it was July '94, July '95. I don't know if I raised more questions than I answered, but I wanted people to be aware of that meeting and the impact of this commission's decision. I will have this disseminated by the clerk to every Council member. I question why the School Board potentially in violation of the Ethics Code when they would be voting on a contract that is reducing the benefits, not increasing the benefits, and the response that I got from the lawyer for the Ethics Commission that the literal language in the Ethics Code says it doesn't matter whether it's a benefit or a detriment, if you vote on it you are in violation of it. Without getting into legal arguments there is some legal belief that that's an erroneous interpretation detriment. But here's why I was concerned about that. This City Council, who by Charter, can never vote to increase or change it's salary for the existing Council, we can only do it for the next Council, '98. Last year and '95 also voted to reduce our benefit package. I am not saying that's the case, and I don't think that would be the ruling, but I am telling you that that would be an absurd interpretation of that ruling. I don't think that's the case at all. I think the serious interpretation

is if you are benefiting yourself or you are doing something to the detriment of someone else by virtue of that. I raise that because we voted to reduce our own medical care package in July. And if you take it by literal definition, you can't vote or reduce your own. Forget about increase, you can't vote to reduce your own benefit package. I don't think that's the case, but I want to raise

it because in a round about way, the Ethics Commission was saying that that's a problem. Not for us, but for the School Board, and since we are bound by Charter, I wonder if that absurd result would ever come out. I don't know."

*Whereas*, The Parks Department and Department of Planning and Development have been working with American Silicon Products, Inc., the Hopkins Homestead Restoration Committee, the Hopkins Family, and the Providence Preservation Society to devise a mutually appropriate plan which would allow American Silicon to expand its existing facility while preserving the integrity of the Esek Hopkins Park; and

*Whereas*, The Providence Redevelopment Agency has considerable experience in areas of redevelopment and construction and monitoring thereof.

*Now, therefore*, The Providence City Council hereby resolves:

1. The Honorable Vincent A. Cianci, Jr., Mayor of the City of Providence, is hereby authorized to convey that certain parcel of land as described in "Exhibit A", attached hereto and made a part hereof (the "subject property") to the Providence Redevelopment Agency in accordance with the Providence Home Rule Charter, Article IV, City Council Section 416 "acquisition and disposition of property" as amended, for the total sum of One-Dollar (\$1.00) for the specific purpose


