Re: Abatement of Lien at 360-362 Carpenter Street

I have reviewed the file for property located at 360-362 Carpenter Street, on Assessors Plat 32, Lot 292. This building was found vacant and open and accessible by this department on November 1, 1971. This property was owned by National Collapsible Tube Company, and the building was marked for demolition by the PRA since it was in the West Broadway Urban Renewal Project. Because of the intent of the Providence Redevelopment Agency to obtain this property and demolish it, the building was vacated in July of 1971 and National Collapsible Tube moved to Lincoln. This building remained vacant until July of 1972, when it was set on fire by vandals.

In January, 1973, National Collapsible Tube Company petitioned the City Council of the City of Providence to have the Providence Redevelopment Agency take full responsibility for the vacant, burnt-out structure. National Collapsible Tube contended that it was the Providence Redevelopment Agency's efforts to purchase and demolish the property for the West Broadway Project that caused this property to become vacant and subsequently burnt. I have no record of this petition ever being acted upon by the City Council. There is no evidence in the Department file indicating that the demolition was performed for the PRA, so I must assume that this building was demolished because the owner failed to take the responsibility for the demolition. On September 11, 1983, the building was demolished by the City of Providence Department of Building Inspection at a cost of \$3,650.00.

Based on the information in our file, this Department has no objection to the lien against this property being waived.
