Resolved, DECREED AND ORDERED

That the certain portion of South Street from its easterly termination at the Harbor Line to a point sixty and seventeen one hundredths (60.17) feet westerly, shown as shaded area and designated by the letters A-B-C-D on the accompanying plan entitled "Providence, R.I., P.W. Dept. - Engineering Office, City Property Section, Plan No. 060802, Date Jan. 5, 1954", has ceased to be useful to the public and the same is abandoned as a highway and the damage to the abutters is appraised at nothing and so awarded, and it is further

ORDERED, That the Superintendent of Street Signs and Numbers be and he is hereby directed to cause a sign to be placed at said portion of South Street abandoned as aforesaid having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper, published in the County of Providence, at least once each week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon each and every owner abutting upon said South Street which has been abandoned, who is known to reside within this State.

PETITION OF THE NARRAGANSETT ELECTRIC
COMPANY FOR THE ABANDONMENT OF THE
EASTERLY 60 FEET OF SOUTH STREET

TO THE HONORABLE THE CITY COUNCIL OF THE CITY OF PROVIDENCE:

Your Petitioner The Narragansett Electric Company respectfully represents:

(1) That it is a corporation created by the General Assembly of the State of Rhode Island and authorized, among other things, to engage in the production, transmission, delivery and furnishing of electricity for light, heat and power.

(2) That your Petitioner is the owner in fee simple of that certain tract or parcel of land situated on the northerly side of South Street extending from Eddy Street easterly to the westerly harbor line of the Providence River; and that it is the owner in fee simple of that other certain tract or parcel of land situated on the southerly side of South Street and which consists of a strip sixty (60) feet in width adjacent to the westerly harbor line of the Providence River and extending from South Street southerly to Point Street; and that both of said tracts or parcels of land are shown as Parcels A and B, respectively, on that plan entitled "PLAN TO ACCOMPANY PETITION FOR ABANDONMENT OF PART OF SOUTH STREET, PROVIDENCE, R. I., NOVEMBER 1953, SCALE 1" = 60'." , attached hereto as Exhibit A and by this reference incorporated herein and made a part hereof.

(3) That as shown on said plan the easterly portion of South Street runs in a general easterly direction from Eddy Street to the westerly harbor line of the Providence River.

(4) That as shown on said plan your Petitioner is the abutting owner on both sides of South Street from said westerly harbor line to a line sixty (60) feet westerly thereof and parallel therewith.

(5) That South Street dead-ends at the westerly harbor line of the Providence River, as shown on said plan, that it has been little used, if at all, by vehicles or by persons on foot other than your Petitioner and its agents or servants, and that accordingly said portion of South Street from said westerly harbor line to a line sixty (60) feet westerly thereof and parallel therewith and shown as a shaded area on said plan has ceased to be useful to the public.

WHEREFORE, your Petitioner prays the Honorable City Council to RESOLVE, ORDER or DECREE that said portion of South Street westerly from the westerly harbor line of the Providence River to a line sixty (60) feet westerly thereof and parallel therewith and shown as a shaded area on said plan has ceased to be useful to the public and that said portion of South Street be abandoned as a highway.

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, January 26, 1954.

This referral is a request for the abandonment of the easterly sixty feet of South Street, adjacent to the westerly harbor line of the Providence River, located on Assessor's Plat 21, containing approximately 2,421 square feet of land area.

On the field trip it was found that the area in question is at present vacant. However, it is enclosed by a wooden fence on the westerly side, and straddled from above by a fuel conveyor structure. To the north and south of the property lies the Narragansett Electric Company, and to the east the Providence River.

South Street dead-ends at the harbor line and is used very little by persons or vehicles.

Gentlemen:

The subject referral received consideration by the City Plan Commission on a telephone poll on Thursday, January 28, 1954.

This referral is a request for the abandonment of the easterly sixty feet of South Street, adjacent to the westerly harbor line of the Providence River, located on Assessor's Plat 21, containing approximately 2,421 square feet of land area.

On the field trip it was found that the area in question is at present vacant. However, it is enclosed by a wooden fence on the westerly side, and straddled from above by a fuel conveyor structure. To the north and south of the property lies the Narragansett Electric Company, and to the east the Providence River.

South Street dead-ends at the harbor line and is used very little by persons or vehicles.


The Commission

Dear Frank:

I have been directed by Chairman Aiello and the Committee on Public Works to communicate with you relative to the Petition of the Narragansett Electric Company for the abandonment of the easterly sixty (60) feet of South Street. This petition had a Public Hearing at the January 28th meeting at which you were present. At that time a representative of the Narragansett Electric Company stated his Company would execute and deliver a draft of an easement so that the City could service the storm sewer.

The Committee, therefore, suggests that you contact the Attorneys, T. Dexter Clark and Paul B. Metcalf, and the Narragansett Electric Company and request that they submit such an easement for your approval and the approval of the City Engineer.

The Committee further suggests that any further action regarding this petition be held in abeyance until advised by you that the easement is in proper form.
