IN AMENDMENT OF AND  
IN ADDITION TO CHAPTER 1984-17 OF THE ORDINANCE OF THE CITY  
PROVIDENCE APPROVED MARCH 9, 1984, ENTITLED "AN ORDINANCE  
APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR

ADDITIONAL ACQUISITION.

### *Be it ordained by the City of Providence:*

1. That Chapter 1984-17 of the Ordinance of the City of Providence, approved March 9, 1984, entitled "An Ordinance Approving and Adopting the Official Redevelopment Plan for the Upper South Providence Revitalization Project" as amended by the following Ordinances of the City Of Providence: Chapter 1990-31 (December 26, 1990), Chapter 1991-17 (April 26, 1991), and Chapter 1992-44 (November 25, 1992) of the Ordinances of the City Providence is hereby further amended as follows:

A. Add the following lots to the acquisition list in Section E. 2 entitled "Proposed Acquisition" as contained and set forth on Page 20 of the certain booklet entitled, "Upper South Providence Official Revitalization Project" which is part of the aforementioned Ordinance:

  3. This ordinance shall take effect upon passage and the City Clerk shall forward a certified copy to the Providence Redevelopment Agency.

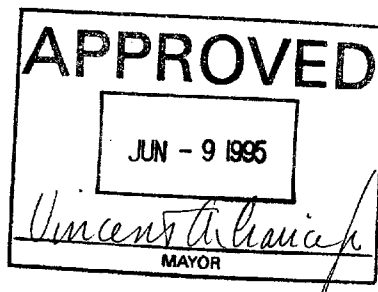
