SUBJECT: Referral No. 1385 - ZONING CHANGE ON THE SOUTHERLY SIDE OF TURNER STREET

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on July 14, 1964.

This referral is to amend the zoning map which accompanies the Zoning Ordinance, as it pertains to Tax Assessor's Lots 80, 81 and 82 on Assessor's Plat 65 located on the southerly side of Turner Street, in the City of Providence, from their present Residential R-4 Multiple Dwelling Zone classification to an M-1 General Industrial Zone classification.


On an inspection and photographic survey it was determined that the property in question was vacant.

Reference is made to Referral No. 1204 from the Committee on Ordinances dated April 28, 1961. At that time a study was made of the feasibility of rezoning an area bounded by Valley Street, Atwells Avenue, Cutler Street, a segment of Cliff Street, Allston Street to Harold Street and Valley Street. The Commission recommended rezoning this area; the City Council referred the petition back to the Committee on Ordinances on March 16, 1961 and it was tabled.





SUBJECT: Referral No. 1387 - ZONING CHANGE AT 25 ALDRICH STREET

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, July 14, 1964.

This referral is a request to change from an R-3 General Residence Zone to an M-1 General Industrial Zone Lots 165 and 166 on Assessor's Plat 57 located at 25 Aldrich Street. The area in question contains 31,028 square feet of land.


On an inspection and photographic survey it was determined that the property in question contained a four level abandoned coal chute and a 1½-story frame industrial structure.

A study was made by the City Plan Commission staff in 1958 of the area in question. At that time a recommendation was made by the Commission to change the existing R-3 Zone to an M-1 Zone, the lots located on Aldrich Street. The Commission recommended approval and the City Council referred it back to the Committee on Ordinances on December 18, 1958.


On an inspection and photographic survey it was determined that the property in question contained a one-story masonry structure containing an electrical supply and warehouse operation.
