RESOLVED, That the City Treasurer, acting under the advice and direction of the Commissioners of the Dexter Donation, is hereby authorized to execute a deed of conveyance to Robert E. Dupre, Jr., 78 Hudson Street, Providence, Rhode Island, 02909, for the purchase of Lot 283, as set out and delineated on City Assessor's Plat 32, located along 25 Hammond Street, containing approximately 5,025 square feet of land, more or less, for the total sum of THREE THOUSAND FIVE HUNDRED (\$3,500) DOLLARS, subject to such terms and conditions established by the Committee on City Property, His Honor the mayor and the City Solicitor, which shall be incorporated into any deed, agreement, or other documents transferring the premises and agreed upon by the parties, and

BE IT FURTHER RESOLVED, That all proceeds from the sale of the land shall be deposited into the Dexter Donation Fund.



IT IS FURTHER RESOLVED, That Resolution No. 379, Approved June 30, 1986, be rescinded.

That the CITY OF PROVIDENCE, a municipal corporation, created by act of the General Assembly of the State of Rhode Island, in the County of Providence, in said State, by its agent, STEPHEN T. NAPOLITANO, CITY TREASURER, acting under the advice and direction of the Commissioners of Dexter Donation, for and in consideration of the sum of THREE THOUSAND FIVE HUNDRED (\$3500) DOLLARS, to it paid by ROBERT E. DUPRE, JR., of the City of Providence, State of Rhode Island, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell and convey unto the said ROBERT E. DUPRE, JR., the following described real estate:

That certain lot or parcel of land lying in said City of Providence, being a part of the Dexter Donation land, and bounded and described as follows:

Lot number eighty-five (85) on a plat of lots of land belonging to the Dexter Donation, recorded in the Office of the Recorder of Deeds in said Providence, in Book of Plat #2, page 7.

Also known as Lot 283 on Assessor's Plat 32.

TO HAVE AND TO HOLD the same with all the rights, privileges and appurtenances thereof and thereto appertaining, unto and to the use of the said ROBERT E. DUPRE, JR., his successors and assigns forever.
