An Ordinance Relating to Article IV, Chapter 17, Section 17-189(6) of the Code of Ordinances (Disability Waiver Request).

SECTION 1. Notwithstanding the language of Section 17-189(6) of the Code of Ordinances which provides that the application to accomplish such [accidental disability] retirement must be filed within eighteen (18) months of the date of the accident," the Retirement Board of the City of Providence, may consider and act upon the accidental disability retirement application of Maria Marino, even though more than eighteen (18) months have passed since the date of the accident which is the averred proximate cause of the above-named applicant for a disability retirement allowance.

SECTION 2. Said application shall be subject to and considered in accordance with all other applicable ordinances, regulations, standards and practices relating to accidental disability retirement applications.

### **PERSONAL EXPRESSION**

**COUNCILMAN ZURIER Requests the privilege of the floor to speak on a Point of Personal Expression and states:**

"There is a rule that one is not supposed to debate or refer to ones colleagues by name. That's something that has been frequently violated in this Chamber and it's particularly ironic that the person who violates rule repeatedly just gave a whole speech about the importance of the rules of the City Council. I would also like to respond to some claims that I'm unfamiliar with what happened in the City Council in 2010. I actually sat up in the gallery up there in late July and watched the proceedings, at which time some members were insulting people from my neighborhood, which I found particularly unfortunate. What happened was is that the City Council did not pass an appropriation, they passed a levy about how to spend taxes and they had to do it at the last minute because if they didn't pass it at the end of July there was a question as to whether the city had the authority to impose taxes. What happened was the City Council approved legislation at the last minute to take away the Homestead Exemption from the landlords. It was procedurally a disgrace. At that time, there were debates between the City Council and the Mayor's Office about whose fault it was. Everybody was pointing the finger at one another. All I'm suggesting is that after having gone through that embarrassing episode, when we're looking at something that doesn't take effect until 2016, I just questioned why you did it, but I certainly respect the majority and I will work within the framework that we all approve. Thank you very much."

**WHEREAS**, Said transfer contemplates a grant of a parcel of Petitioner's property, which consists of approximately 4,803 square feet on Assessor's Plat 101 (formerly a portion of Lot 4) to the City in addition to the sum of Sixty-Five Thousand Dollars (\$65,000); and

**WHEREAS**, An appraisal of the property was completed by Thomas O. Sweeney a qualified real estate appraiser in the State of Rhode Island, of a net sum of Sixty Five Thousand Dollars (\$65,000), said appraisal having been adopted as the City's appraisal pursuant to Sec. 416 of the Home Rule Charter of 1980; and

**WHEREAS**, The provisions relative to the exchange of property contained in Sec. 416 (7) of the Home Rule Charter of 1980 have been duly satisfied, and

**WHEREAS**, The matter was considered and approved by the City Council Committee on City Property at its meeting of April 16, 2014, with due consideration of the aforesaid appraisal as well as an engineer's diagram which accurately depicts the parcels under consideration.

**NOW, THEREFORE, BE IT RESOLVED**, That the City Council approves the exchange of the parcels of property aforesaid in addition to the sum of Sixty Five Thousand Dollars (\$65,000) to the City from Petitioner, pursuant to that certain Purchase and Sale Agreement between the Petitioner and the City, substantially in the form attached hereto, subject to approval as to form and correctness by the City Solicitor; and


