No. 77 AN ORDINANCE

IN AMENDMENT OF CHAPTER 2000-25, APPROVED AUGUST 9, 2000, OF ORDINANCES OF THE CITY OF PROVIDENCE MAKING AN APPROPRIATION OF FOUR HUNDRED FORTY SEVEN MILLION, THREE HUNDRED THIRTY FIVE THOUSAND, THREE HUNDRED NINETY SIX (\$447,335,396) FOR THE FISCAL YEAR ENDING JUNE 30, 2001, AS AMENDED.

Be it ordained by the City of Providence:

WHEREAS, the receipts for the fiscal year ending June 30, 2001, have been estimated to amount to FOUR HUNDRED FORTY SEVEN MILLION, THREE HUNDRED THIRTY FIVE THOUSAND, THREE HUNDRED NINETY SIX (\$447,335,396), as amended.
