RESOLUTION OF THE CITY COUNCIL

No. 250

Approved May 8, 1981

WHEREAS, The City Council of the City of Providence has long been in favor of increased aid to low and middle income families by the planning, implementation and development of housing, and

WHEREAS, The Council recognizes the desperate need for such housing in order to provide decent accommodations for low and middle income families in the City of Providence, and

WHEREAS, The Council has continuously supported efforts to bring together federal, state and private funding authorities for the purpose of providing such housing, and

WHEREAS, The House of Representatives is considering a Bill, designated as 81H-6350 seeking to authorize the Providence Housing Development Corporation to take, hold, transmit and convey real and personal property in an amount not to exceed \$20,000,000 for the express purpose of constructing and maintaining housing for low and middle income families,

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence does hereby vote to support the legislation hereinbefore mentioned, and urge passage of same by the General Assembly and the Governor of the State of Rhode Island, and

BE IT FURTHER RESOLVED, That the said Council instruct the Clerk of the City of Providence to submit certified copies of the foregoing Resolution to the Speaker of the House of Representatives, the Senate Majority Leader, and the Governor of the State of Rhode Island.

It is enacted by the General Assembly as follows:

1 SECTION 1. The Providence Housing Development Corporation,
2 a non-business corporation incorporated on April 9, 1981, is
3 hereby authorized to take, hold, transmit, and convey real and
4 personal estate to an amount not exceeding twenty million dollars
5 (\$20,000,000.), so long as said estate is used for the purposes
6 for which said corporation was incorporated.

7 SECTION 2. This act shall take effect upon passage.
