Resolution Authorizing the Submission of Project Proposals by the Department of Planning and Urban Development for Inclusion in the Annual Statewide Overall Economic Development Program, (OEDP).

*Whereas, The Rhode Island Statewide Planning Program is responsible for the preparation of the Overall Economic Development Program which covers all qualified areas of the State and insures the eligibility for the full range of Economic Development Administration benefits under the Public Works and Economic Development Act and other Acts administered by EDA, including,*

- grants to help build public facilities essential to long-range industrial and commercial growth
- financial assistance to help private enterprise expand and establish job-generating operations, and
- planning grants and technical assistance to help solve problems blocking growth, and

*Whereas, The Public Works Employment Act of 1976, Section 108(g) states that "States and local governments making application under this Act should (1) relate their specific requests to existing approved plans and programs of a local community development or regional development nature . . ." and*

*Whereas*, The City of Providence deems it necessary and in the public interest (1) to develop a systematic approach to analyze the local economy, (2) to define development goals, (3) to determine project opportunities and (4) to formulate and implement a development program; and

*Whereas*, Said Section 302(a) of the Public Works and Economic Development Act, as amended in 1974, provides for 75 percentum of the estimated cost of such activities or undertakings; and

*Whereas*, The City of Providence, in order to obtain said Economic Development Planning Grant, must assume the local share which is

25 per centum of the total estimated cost of \$100,000.00 to be met by \$10,000.00 in contractual services under the Downtown Economic Study funded through the Mayor's Office of Community Development and \$15,000.00 in in-kind services.

*Now, Therefore, Be It Resolved*, By the City Council of the City of Providence as follows:

1. It is hereby found necessary and in the public interest to make an application to the Economic Development Administration for an Economic Development Planning Grant under Section 302(a) of the Public Works and Economic Development Act of 1965 (Public Law 89-136) as last amended (Public Law 94-273) for the aforementioned study.

2. The Department of Planning and Urban Development is hereby authorized and designated as the representative of the City for the filing of an application with the Economic Development Administration, to prepare all requisitions and documents necessary for the receipt of funds from said Economic Development Administration, and to do all work necessary to carry out the terms of any contract between the City and the Economic Development Agency arising out of said application for an Economic Development Planning Grant.

3. That United States of America and the Economic Development Administration be, and they hereby are assured of full compliance by the City of Providence with all regulations of the United States Government effectuating the receipt of Federal grants under the Public Works and Economic Development Act as amended.
