ORDINANCE SECOND READING

The Following Ordinance was in City Council February 18, 2021, Read and Passed the First Time and is Returned for Passage the Second Time:

COUNCILOR SALVATORE, COUNCILWOMEN ANTHONY, CASTILLO, COUNCILMEN ESPINAL, GONCALVES, COUNCILWOMAN LAFORTUNE, COUNCILOR MILLER, COUNCILWOMAN HARRIS AND COUNCILWOMAN RYAN

An Ordinance Amending Article XIII "Motor Vehicle Repair Business" of Chapter 14 "Licenses" of the Providence Code of Ordinances.

Section 1. Chapter 14, "Licenses", Article XIII, "Motor Vehicle Repair Business" is hereby amended as follows:

ARTICLE XIII. - MOTOR VEHICLE REPAIR BUSINESS

Sec. 14-260. - License required.

No person shall engage in the business of motor vehicle repair within the City of Providence unless such person shall be so licensed by the board of licenses of the City of Providence.

Sec. 14-261. - Motor vehicle repair business defined.

"Motor vehicle repair business" shall be any place, establishment, garage, outdoor work area or work area enclosed within a building, including a used automobile dealership, where repairs are made or caused to be made to motor vehicles, including engines, carburetors, brakes, transmissions, muffler systems, electrical systems and general running gear of motor vehicles including auto body repairs, as well as the repair and/or replacement of motor vehicle tires. Motor vehicle repair business shall not include a new automobile dealership.

Sec. 14-262. - License application; fee.

- (a) Every applicant for a license required pursuant to section 14-260 above shall submit the following information, on a form provided by the board of licenses:
 - (1) Full name, including middle name, any aliases, address, date of birth, and social security number of applicant and/or principals of any applicant corporation.
 - (2) Location of the proposed motor vehicle repair business.
 - (3) Radius map and property owner list identifying owners of property within a two-hundred-foot radius of the motor vehicle repair business as appears on the most current property tax list certified by the tax assessor of the city.
- (b) All applications shall be accompanied by an application fee of one hundred dollars (\$100.00), plus the costs of advertising, posting and mailing as determined by the board of licenses.

Sec. 14-263. - Hearing and notice.

The board of licenses shall hold a public hearing on any application for a motor vehicle repair business license;

- (1) Notice of such hearing shall be published in a newspaper of general circulation in the city once a week for at least two (2) weeks prior to the public hearing.
- (2) Notice of said hearing shall also be mailed to all owners of property within a two-hundred-foot radius of the proposed site of the motor vehicle repair business as listed on the most current property tax list certified by the tax assessor of the city.

Sec. 14-264. - Zoning approval.

Prior to holding a public hearing on applicant's license, the board of licenses shall submit the application for review to the director of the department of inspection and standards. The director of inspection and standards shall report to the board of licenses whether or not a motor vehicle repair business is allowed in the proposed location pursuant to the zoning ordinance of the city.

Sec. 14-265. - Fire safety regulations.

Prior to holding a public hearing on applicant's license, the board of licenses shall submit the application for review to the chief of the fire department. The chief of the fire department shall report to the board of licenses whether or not the proposed motor vehicle repair business meets all applicable fire code and fire safety regulations. Sec. 14-266. - Criminal records.

Prior to holding a hearing on applicant's license, the board of licenses shall submit the application to the chief of police for review. The chief of police shall report to the board of licenses whether or not the applicant or any principals of the applicant's corporation have a criminal record.

Sec. 14-267. - Requirements for license approval.

No license shall be granted for a motor vehicle repair business unless the following conditions are met:

- (1) The motor vehicle repair business must be allowed in the proposed location pursuant to the zoning ordinances of the city.
- (2) The motor vehicle repair business must be substantially operated within a building.
- (3) The motor vehicle repair business must meet all applicable fire code and fire safety regulations.
- (4) The motor vehicle repair business must be operated in a lawful manner, in conformity with all applicable federal, state and municipal laws, statutes, ordinances and regulations.
- (5) The criminal record(s) of the applicant(s) and/or principal(s) of the applicant corporation shall be considered.

Sec. 14-268. - Renewal of license.

All licenses to engage in a motor vehicle repair business must be renewed annually.

Sec. 14-269. - Disposal of Tires

Any licensed motor vehicle repair business shall dispose of all used motor vehicle tires handled by the business by delivering said tires to a facility operated by the Rhode Island Resource Recovery Corporation designated for that purpose, or to a privately operated tire storage or tire recycling or recovery facility licensed by the director of environmental management for that purpose, or by delivery for transportation to an out-of-state recycling facility as required by Rhode Island General Law §23-63-2. All licensed motor vehicle repair businesses shall, upon request, provide receipts for the prior twelve (12) months from the date of the request that evidence the proper disposal of all used motor vehicle tires in compliance with this Section 14-269.

Sec. 14-270. - Display of license.

All licenses granted under the provisions of this article shall be kept on display in a conspicuous place within the motor vehicle repair business so licensed. Sec. 14-271. - Annual license fee.

The annual fee for all licenses required by section 14-260 shall be one hundred dollars (\$100.00).

Sec. 14-272. - Suspension or revocation.

Any person licensed to engage in or operate a motor vehicle repair business who shall violate any of the conditions or restrictions imposed upon the issuance of such license, or who shall have submitted false information in the application to obtain such license, or who shall violate any applicable federal, state or municipal laws, statutes, ordinances or regulations in the operation of such motor vehicle repair business, shall suffer suspension or revocation of said license; in addition, said license may be revoked at any time for just cause other than those specified above, including violation of other provisions of the Code of Ordinances and/or any federal or state laws.

Sec. 14-273. - Violation.

Any person engaging in or operating a motor vehicle repair business without first obtaining a license pursuant to this article shall be subjected to a fine of five hundred dollars (\$500.00) or imprisonment not exceeding six (6) months for each offense.

Sec. 14-274. - Enforcement.

The provisions of this article shall be enforced by the Providence Police Department and the Rhode Island State Police.

Sec. 14-275. - Severability.

If any provision of this article, or application thereof to any person or circumstances, is held unconstitutional, illegal, or otherwise invalid, the remaining provisions of this chapter and the application of such provisions to other persons or circumstances, other than those to which it is held invalid, shall not be affected thereby.

Section 2. This Ordinance shall take effect upon passage.

Resolution Honoring the Life and Legacy of John "Johnny" Britto.

WHEREAS, John "Johnny" Britto, 87, of Schofield Street, Fox Point passed away on Monday, January 25, 2021; and

WHEREAS, John V. Britto was a son of the late Joao and Rufina (Silva) Britto; and

WHEREAS, As a lifelong resident of the Fox Point neighborhood, John "Johnny" Britto was not just a devoted husband, father, and grandfather, but he was a fixture in the community and inspiration; and

WHEREAS, John "Johnny" Britto served as a longshoreman for many years, was an Army veteran of the Korean War, played short term for the Harlem Globetrotters, and the New York Yankees farm team; and

WHEREAS, John "Johnny" Britto served the Fox Point community for over 60 years as a coach, friend, and mentor to kids of all ages via his role as the Athletic Director of the Fox Point Boys & Girls Club on Wickenden Street, which is known as the oldest continually operating Boys and Girls Club in the United States, celebrating over 150 years of operation; and

WHEREAS, Mr. Britto was a friend and huge fan of Frank Sinatra, had a distinctive whistle, loved Necco wafers, pool, and billiards, and could sink a full-court hook shot repeatedly; and

WHEREAS, In the early 1990s the Gano Street neighborhood basketball courts were named in his honor and he received numerous awards including Community Hero, Jefferson Award, Basketball Hall of Fame, Mr. Boys & Girls Club, Urban League, and the Key to Success; and

WHEREAS, Upon and prior to his retirement in 2017, Mr. Britto was additionally recognized by countless City officials and was duly awarded the Outstanding Citizenship Hero Award by Blue Cross & Blue Shield of Rhode Island and American Cross Rhode Island in recognition of his giving spirit and selfless service to the City of Providence; and

WHEREAS, Johnny was married to the late Eufemia “Fama” Britto of Schofield Street for 57 years; and

WHEREAS, Mr. Britto spent a lifetime leading by example for the youth of the Fox Point neighborhood; and

WHEREAS, Mr. Britto impacted thousands of families in the City of Providence and truly enjoyed fostering deep connections and serving their neighborhood through his cheerful disposition and charming personalities; and

WHEREAS, Through his kindness, work ethic, unquestioned integrity, and unwavering commitment to the young men and women of Providence, Mr. Britto has helped to inspire the City’s youth, revitalized the City’s neighborhoods, and strengthened the community of Fox Point and the entire City of Providence.

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence does hereby honor the life, work, and legacy of John “Johnny” Britto.

and teachers with her enduring commitment to her education, her unwavering spirit and humor,
and her mischievous and ever so present smirk and twinkle in her eyes; and

WHEREAS, With a love for donuts, reading, baking, The Simpsons and Paris, Anaija's
sparkling personality shone bright through the many trials of childhood illness; and

WHEREAS, As a loving daughter, protective little sister, and amazing friend, Anaija
touched the lives of all who knew her.

WHEREAS, United States manufacturers have voluntarily worked to reduce releases of long-chain PFAS due to their toxic effects on human health; and

WHEREAS, The PFAS with fewer than eight (8) carbon-fluorine bonds currently being used as alternatives to PFOA and PFOS are also highly persistent and subject to long-range transport; and

WHEREAS, These alternative PFAS have similar potential for harm as the long-chain PFAS; and

WHEREAS, Over two hundred (200) scientists from all over the world have signed a statement calling for governments to limit the use of PFAS while studies determine the safety of these chemicals, given their persistence in the environment, potential for harm, and lack of adequate data proving safety; and

WHEREAS, Food packaging contains pfas in order to resist grease and other fats from sticking to the paper packaging; and

WHEREAS, House Bill 2021 H-5356 and Senate Bill 2021 S-0110 eliminate the manufacture, sale, and distribution for use in the state food packaging to which PFAS have been intentionally added in any amount.

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence endorses and urges passage by the Rhode Island house of Representatives of House Bill 5356, An Act Relating to Health and Safety-PFAS in Food Packaging.

WHEREAS, Lesbian, gay, transgender, and queer people lack basic legal protections in states across the country; and

Resolution Regarding the Providence Affordable Housing Trust Fund Bonds.

WHEREAS, The City of Providence, Rhode Island (the “City”), a body politic and corporate duly organized and existing as a political subdivision and municipal corporation of the State of Rhode Island (the “State”) is authorized by the laws of the State and its Home Rule Charter to make appropriations of municipal revenues by ordinance pursuant to ARTICLE VIII of the City of Providence Home Rule Charter; and

WHEREAS, Pursuant to Ordinance No. 325, the City of Providence City Council, unanimously voted to approve supplemental appropriations of municipal revenues to the Providence Housing Trust in furtherance of the goals of the Providence Redevelopment Agency (the “Agency”) to issue bonds to capitalize the Providence Housing Trust; and

WHEREAS, On February 24, 2021, the Providence Redevelopment Agency unanimously voted to approve the issuance of Special Obligation Bonds (Multifamily Housing Capitalization Project) Series 2021 A (Federally Taxable) (the “2021 Series A Bonds”), a copy of such approved resolution having been delivered to the City Clerk, (i) to provide a source of funds for the purposes of funding the Providence Housing Trust in connection with its program to finance qualified affordable multifamily housing projects in the City; (ii) to fund a debt service reserve fund, if required; and (iii) to pay costs of issuance of the 2021 Series A Bonds (the “Project”), such 2021 Series A Bonds to be issued pursuant to a Trust Indenture by and among the Agency, the City and The Bank of New York Mellon Trust Company, N.A., as trustee (the “Trustee”) and a First Supplemental Indenture (the “First Supplemental Indenture, and together with the Trust Indenture, the “Indenture”) by and among the Agency, the City and the Trustee; and

WHEREAS, The 2021 Series A Bonds to be issued by the Agency are not a debt of the City, the State or any political subdivision other than the Agency, and neither the City nor the State, or any political subdivision other than the Agency, are liable for them, nor in any event are the 2021 Series A Bonds payable out of any funds or properties other than those of the Agency as more fully set forth in the Indenture. The 2021 Series A Bonds do not constitute an indebtedness within the meaning of any constitutional or statutory debt limitation or restriction; and

WHEREAS, the Project is necessary for the City to perform essential governmental functions.

NOW, THEREFORE, BE IT RESOLVED THAT:

SECTION 1. The findings set forth in the preceding recitals are hereby made and confirmed.

SECTION 2. The City Council hereby authorizes the City Treasurer and the Mayor, acting on behalf of the City, to finance the Project through the execution and delivery by an Authorized Officer (as defined below) signing singly, of the Trust Indenture and Supplemental Indenture, and such other agreements, certificates and other documents in such form as they may deem necessary or desirable, to implement the Project in connection therewith (the "Financing Documents". Payments by the City pursuant to the Financing Documents in sums sufficient to pay principal, interest on, and the redemption price of, the 2021 Series A Bonds shall be subject to and dependent on, annual appropriations made therefor by the City Council.

SECTION 3. The form and other details, terms and conditions of the Financing Documents shall be fixed by the Mayor, City Treasurer, Director of Finance or Chief Financial Officer (each, an “Authorized Officer”), signing singly. Any one Authorized Officer, signing singly, is authorized to enter into, execute and deliver on behalf of the City the Indenture and the Supplemental Indenture, and perform its obligations thereunder, subject to annual appropriation by the City Council.

SECTION 4. In order to assist in the sale of the 2021 Series A Bonds, the City hereby authorizes the use and distribution of a Preliminary Official Statement ("POS"), including the addition thereto of an Information Statement and Financial Statements, to prospective purchasers of the 2021 Series A Bonds in substantially the form submitted to the City in connection with the offering of the 2021 Series A Bonds, and further authorizes the City to deem final within the meaning of Rule 15(c)(2)-12 of the Securities and Exchange Act of 1934 (except for permitted omissions), the POS describing the 2021 Series A Bonds; and any Authorized Officer is hereby authorized to prepare and distribute a final Official Statement, substantially in the form of the Preliminary Official Statement, including such changes to the Official Statement as the City in its discretion may approve, such approval to be conclusively evidenced by the execution and delivery thereof by an Authorized Officer.

SECTION 5. The Authorized Officer is hereby authorized and empowered individually on behalf of the City to approve the rates and terms at a sale of the 2021 Series A Bonds, such sale to be held on such date as recommended by Hilltop Securities, Inc. Municipal Advisor to the Agency and the City, or such other date in the event such sale is extended, postponed or delayed, and to execute, acknowledge and deliver in the name of and on behalf of the City any and all documents, agreements and instruments to effectuate the negotiated sale of the above authorized 2021 Series A Bonds, including without limitation, a Bond Purchase Agreement by and among the Agency, the City and Raymond James and Associates, Inc., as Underwriter ("Underwriter") in such form as they deem advisable, with such changes therein as may be necessary or as an Authorized Officer may approve, such approval to be conclusively evidenced by the execution and delivery thereon.

SECTION 6. That the City hereby approves the Trust Indenture and the First Supplemental Indenture, in such form as they deem advisable, and any one of the Authorized Officers shall be authorized and directed to execute, acknowledge and deliver in the name and on behalf of the City the Financing Documents in such form as they deem advisable, with such changes therein as may be necessary or as the Authorized Officer may approve, such approval to be conclusively evidenced by the execution and delivery thereon.

SECTION 7. Nothing contained in this Resolution, the Financing Documents or any other instrument shall be construed with respect to the City as incurring a pecuniary liability or charge upon the general credit of the City or against its taxing power, nor shall the breach of any agreement contained in this Resolution, the Financing Documents or any other instrument or document executed in connection therewith impose any pecuniary liability upon the City or any charge upon its general credit or against its taxing power, except to the extent that the payments payable under the Financing Documents are special limited obligations of the City. In no event shall the full faith and credit and the taxing power of the City be pledged directly or indirectly to the payment of the 2021 Series A Bonds.

SECTION 8. The Mayor and the Director of Finance are authorized to take all actions necessary to comply with federal securities laws including Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") and to execute and deliver a Continuing Disclosure Certificate in connection with the 2021 Series A Bonds in the form as shall be deemed advisable by an Authorized Officer in order to comply with the Rule. The City hereby covenants and agrees that it will comply with and carry out all of the provisions of the Continuing Disclosure Certificate, as it may be amended from time to time. Notwithstanding any other provision of this Resolution or the 2021 Series A Bonds, failure of the City to comply with the Continuing Disclosure Certificate shall not be considered an event of default; however, any bondholder may take such actions as may be necessary and appropriate, including seeking mandate or specific performance by court order, to cause the City to comply with its obligations under this Section and under the Continuing Disclosure Certificate.

SECTION 9. This Resolution shall take effect upon its passage and the terms of this Resolution providing that the City's payments are subject to annual appropriation of funds and that such payments do not constitute general obligations of the City supersede any prior City Council actions relating to bonds and notes that the Agency may issue from time to time for the Project.
