Dear Council Members:

Over the past few years, the Judge Thomas J. Paolino Zoning Code Study Commission, under the leadership of Councilman Thomas M. Glavin, has worked to develop a new zoning code to direct the growth in the City. The development of this new zoning ordinance has been a long and tedious process. The Commission, which started only to update our existing zoning ordinance, found that much more was needed. The Commission spent many hours looking at the needs of the City as a whole and of each of the neighborhoods. All aspects of the zoning ordinance were examined.

The Commission and staff of the Department of Planning and Development was always ready to meet with interested groups to discuss the zoning ordinance. Many very helpful comments were received and incorporated into the zoning ordinance. Once the draft was complete, the Commission held neighborhood meetings. Based on the comments received, further revisions to the zoning ordinance were made. The Commission has forwarded this zoning ordinance to me urging its adoption.

The adoption of this zoning ordinance will protect the residential character of our neighborhoods, set the framework for the revitalization of downtown, direct the redevelopment of our waterfront, and, lead the City into the Twenty-First Century. I urge you to adopt this zoning ordinance and set the tone for growth and change in the city.
