That that certain portion of Dewey Street from Eastwood Avenue northerly to its northerly termination, shown as cross-hatched area and designated by the letters A-B-C-D-A on the accompanying plan entitled "Providence, R. I., P. W. Dept.- Engineering Office, Street Line Section, Plan No. 063582, Date November 3, 1972", has ceased to be useful to the public and the same is abandoned as a public highway and the damage to the abutters is appraised at nothing and it is further

ORDERED,

That the Director of Public Works, be and he is hereby directed to cause a sign to be placed on that certain portion of Dewey Street from Eastwood Avenue northerly to its northerly termination, abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED,

That after the entry of this order or decree, the City Clerk shall cause a notice thereof to be published in a newspaper published in the County of Providence at least once each week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting that certain portion of Dewey Street from Eastwood Avenue northerly to its northerly termination, which has been abandoned, who is known to reside within this State.

Gentlemen:

This petition from the Committee on Public Works is a request for the abandonment of that portion of Dewey Street which runs from Eastwood Avenue northerly for approximately 100 ft. to its termination.

Inspection revealed that the portion of Dewey Street in question is neither curbed nor paved and is presently used as access to garages on adjacent Lot No. 500. The land beyond the northerly termination of the street drops sharply to the grounds of the Hartford Housing Development.

Since this portion of Dewey Street serves no purpose as a public highway,




