Holton, Chief Engineer of the Water Supply Board, and entitled "Map of Land in the Town of North Providence to be Leased to the Town of Smithfield for Pipe Line and Pumping Station", for the purpose of erecting on a portion thereof a pumping station and installing thereon a pipe line to carry water from the water supply system of the City of Providence to the Town of Smithfield upon certain terms and conditions and in substantially the form of the lease hereto attached and made a part hereof by reference.





- Montcalm Court - from Winter Street to Spring Street
- Knight Street - from Cranston Street to Lester Street


Attached hereto are two (2) maps showing the streets in yellow requested for abandonment at the present time.

 MAP NO. 3


