Be it ordained by the City of Providence:

Whereas, The Providence City Charter directs that a Comprehensive Plan for the City be prepared and adopted; and the Rhode Island Comprehensive Planning and Land Use Regulation Act (RIGL 45-22.2) mandates that every community shall prepare a comprehensive plan every five (5) years that provides a basis for rational decision making regarding the long-term physical development of the municipality.

Whereas, The Providence City Plan Commission, pursuant to Article X, Section 1013 (A) of the Providence Home Rule Charter, has approved *Providence 2000: The Comprehensive Plan* which

contains goals and policies relating to land use, housing, economic development, natural and cultural resources, community services and facilities, open space and recreation, traffic and circulation, and an implementation program.

Whereas, Providence 2000: The Comprehensive Plan recommends that a series of citywide issue-specific plans and area-specific plans be created to implement the goals and policies of the comprehensive plan.

Whereas, The City of Providence and others sponsored the preparation of the *I-195 Old Harbor Plan*, which contains goals, policies and an implementation plan for the development of land in the Old Harbor area which will become available after the relocation of Interstate 195.

Whereas, The Providence City Plan Commission approved the *I-195 Old Harbor Plan* on January 19, 1994 after a public hearing, and

authorized the Director of the Department of Planning and Development to submit said plan to the City Council for its review and approval.

It is ordained by the City of Providence that:

1. *The I-195 Old Harbor Plan* has been prepared in accordance with the provisions of the Providence Home Rule Charter and the Rhode Island Comprehensive Planning and Land Use Regulation Act.

2. *The I-195 Old Harbor Plan*, a document consisting of text, figures, charts, tables, appendix and maps, is hereby approved, adopted and designated as part of the Official Comprehensive Plan for the city and all city officials, departments, boards, commissions, authorities and agencies are hereby directed to carry out this plan.

3. In enacting this Ordinance and in adopting *The I-195 Old Harbor Plan*, the City Council intends to establish general policies and specific recommendations for the development of the Old Harbor area in conformance with this plan.

4. In order to implement *The I-195 Old Harbor Plan*, the City Council pledges its cooperation in helping to carry out said plan and all city officials, departments, boards, commissions, authorities and agencies of the City of Providence are directed to exercise their functions and powers in a manner consistent with said plan.

5. This Ordinance shall take effect and become enforceable upon adoption by the City Council and approval of the Mayor. The City Clerk is hereby directed to forward a certified copy of this Ordinance to the City Plan Commission upon its approval. *The I-195 Old Harbor Plan* shall not become official until its approval by the state of Rhode Island pursuant to RIGL 45-22.2 and any rules and regulations adopted thereto.

Be it ordained by the City of Providence:

Whereas, The Providence City Charter directs that a Comprehensive Plan for the City be prepared and adopted; and

Whereas, The Rhode Island Comprehensive Planning and Land Use Regulation Act (RIGL 45-22.2) mandates that every community shall prepare a Comprehensive Plan every five (5) years that provides a basis for rational decision making regarding the long term physical development of the municipality.

Whereas, The Providence City Plan Commission, pursuant to Article X, Section 1013 (A) of the Providence Home Rule Charter, has prepared *Providence 2000: The Comprehensive Plan*, which contains goals and policies relating to land use, housing, economic development, natural and cultural resources, community services and facilities, open space and recreation, traffic and circulation, and an implementation program.

2. *Providence 2000: The Comprehensive Plan*, a document consisting of text, figures, charts, tables, appendix and maps, is hereby approved,

An Ordinance Adopting Providence 2000: The

adopted and designated as the Official Comprehensive Plan for the city and all city officials, departments, boards, commissions, authorities and agencies are hereby directed to carry out this plan.

3. In enacting this Ordinance and in adopting *Providence 2000: The Comprehensive Plan*, the City Council intends to establish general citywide policies for the development and renewal of the city and its neighborhoods in conformance with this Plan.

4. In order to implement *Providence 2000: The Comprehensive Plan*, the City Council pledges its cooperation in helping to carry out said Plan and city officials, departments, boards, commissions, authorities and agencies of the City of Providence are directed to exercise their functions and powers in a manner consistent with said Plan.

5. This Ordinance shall take effect and become enforceable upon adoption of the City Council and approval of the Mayor. The City Clerk is hereby directed to forward a certified copy of this Ordinance to the City Plan Commission upon adoption. *Providence 2000: The Comprehensive Plan* shall not become official until its approval by the State of Rhode Island pursuant to RIGL 45-22.2 and any rules and regulations adopted thereto.

An Ordinance Adopting the Park, Recreation and Open Space Plan, 1991-1995 as Plan No. 1 of the Comprehensive Plan Series of Providence 2000: The Comprehensive Plan, as Amended.

Be it ordained by the City of Providence:

Whereas, The City Plan Commission (hereinafter called the "Commission"), pursuant to Article X, Section 1013 (A) of the Providence Home Rule Charter, has formulated and has submitted to the City Council for its consideration a plan entitled the *Park, Recreation and Open Space Plan 1991-1995*; and

Whereas, The Commission, which is the duly designated and acting official planning body for the City of Providence, pursuant to Article X, Sections 1013 (A) (1) and 1014 (A) and (B), has reviewed, evaluated and approved the said, *Park, Recreation and Open Space Plan 1991-1995* on the 17th day of April, 1991, and authorized the Director of the Department of Planning and Development to submit said Plan to the City Council for its review and approval; and

Whereas, The *Park, Recreation and Open Space Plan 1991-1995* is recognized by the Commission as Plan Number 1 of the Comprehensive Plan Series of *Providence 2000: The Comprehensive Plan* as an adopted policy guide concerning the general development of parks, recreation and open space in the community as a whole.

It is ordained by the City of Providence that:

1. The *Park, Recreation and Open Space Plan 1991-1995* is Plan Number 1 of the Comprehensive Plan Series of *Providence 2000: The Comprehensive Plan*.

2. In enacting this Ordinance, the City Council intends to establish general city-wide policies for development and renewal of City Parks and Open Space in conformance with said Plan.

3. Implementation of Said Plan and such policies shall promote and protect the neighborhoods of the City of Providence and its citizenry.

4. The *Park, Recreation and Open Space Plan 1991-1995* is hereby adopted and designated as the Official Park, Recreation and Open Space Plan 1991-1995 for the City. The Commission and other appropriate Boards, Commissions and City Departments are hereby authorized to carry out this Plan.

5. In order to implement said approved Plan, the City Council pledges its cooperation in helping carry out said Plan and requests the Board of Park Commissioners, the Department of Public Parks, the Department of Recreation, and the Depart-

ment of Planning and Development, and the various officials, departments, boards and agencies of the City of Providence having administrative responsibilities in the premises likewise to cooperate to such end and to exercise their functions and powers in a manner consistent with said Plan.

6. This Ordinance shall take effect and become enforceable upon adoption by the City Council and approval of the Mayor. The City Clerk is hereby directed to forward a certified copy of this Ordinance to the City Plan Commission upon approval. *The Park, Recreation and Open Space Plan 1991-1995* shall not become official until its approval by the state of Rhode Island pursuant to RIGL Chapter 45-22.2 and any rules and regulations adopted thereto.

An Ordinance Adopting a Plan for Preservation as Plan No. 2 of the Comprehensive Plan Series of Providence 2000: The Comprehensive Plan to direct the Preservation of Historic Resources in Providence, as Amended.

Be it ordained by the City of Providence:

Whereas, The Providence City Charter directs that a Comprehensive Plan for the City be prepared and adopted; and the Rhode Island Comprehensive Planning and Land Use Regulation Act (RIGL 45-22.2) mandates that every community shall prepare a comprehensive plan every five (5) years that provides a basis for rational decision making regarding the long-term physical development of the municipality.

A *Plan for Preservation* shall not become official until its approval by the state of Rhode Island pursuant to RIGL 45-22.2 and any rules and regulations adopted thereto.

An Ordinance Adopting Downcity Providence Master Plan and Implementation Plan as Plans No. 1A and No. 1B of the Area Plan Series of Providence 2000: The Comprehensive Plan to Direct the Development of Downtown, as Amended.

Be it ordained by the City of Providence:

Whereas, The Providence City Charter directs that a Comprehensive Plan for the City be prepared and adopted; and the Rhode Island Comprehensive Planning and Land Use Regulation Act (RIGL 45-22.2) mandates that every community shall prepare a basis for rational decision making regarding the long-term physical development of the municipality.

Whereas, The Providence City Plan Commission, pursuant to Article X, Section 1013 (A) of the Providence Home Rule Charter, has approved *Providence 2000: The Comprehensive Plan* which contains goals and policies relating to land use, housing, economic development, natural and cultural resources, community services and facilities, open space and recreation, traffic and circulation, and an implementation program.

It is ordained by the City of Providence that:

1. *Downcity Providence: Master Plan and Implementation Plan* has been prepared in accordance with the provisions of the Providence Home Rule Charter and the Rhode Island Comprehensive Planning and Land Use Regulation Act (RIGL 45-22.2)

2. *Downcity Providence: Master Plan and Implementation Plan*, a document consisting of text, illustrations, tables, appendix and maps, is hereby approved, adopted and designated as part of the Official Comprehensive Plan for the city and all city officials, departments, boards, commissions, authorities and agencies are hereby directed to carry out this plan.

3. In enacting this Ordinance and in adopting *Downcity Providence: Master Plan and Implementation Plan*, the City Council intends to establish general policies and specific recommendations for the development and renewal of the old retail core of downtown in conformance with this Plan.

4. In order to implement *Downcity Providence: Master Plan and Implementation Plan*, the City Council pledges its cooperation in helping to carry out said plan and all city officials, departments, boards, commissions, authorities and agencies of the City of Providence are directed to exercise their functions and powers in a manner consistent with said Plan.

5. This Ordinance shall take effect and become enforceable upon adoption by the City Council and approval of the Mayor. The City Clerk is hereby directed to forward a certified copy of this Ordinance to the City Plan Commission upon its approval. *Downtown Providence: Master Plan and Implementation Plan* shall not become official until its approval by the state of Rhode Island pursuant to RIGL 45-22.2 and any rules and regulations adopted thereto.

An Ordinance Regulating the Removal of Snow in the City of Providence, as Amended.

Be it ordained by the City of Providence:

Section 1. All owners of any building or lot bordering upon any street, highway or public place within the City shall within the first four (4) hours of daylight after the end of any snowfall, or the deposit of snow on the sidewalk of said building or lot from any cause whatever:

(a) Remove or cause to be removed all snow from a path not less than three (3) feet in width of the entire border in or on said street, highway, or public place;

(b) Remove or cause to be removed all snow from around any fire hydrant on the sidewalk in front of said building or lot;

(c) Remove or cause to be removed all snow from the opening of any catch basin in the sidewalk of said building or lot;

(d) Remove or cause to be removed all snow from pedestrian-access ramps cut into street curbs bordering said building or lot;

Any person found guilty of violating this Section shall be fined not less than \$25.00 nor more than \$300.00.

Section 2. This Ordinance shall take effect upon its passage.

C. Section A. Legal Description of the Project Boundaries under Chapter K. Exhibit shall be amended as follows:

Beginning at a point, said point being located at the westerly side of Valley Street at the intersection of the northerly line of San Souci Drive.

Thence running westerly along the northerly side of San Souci Drive to its intersection with the northeasterly side of Manton Avenue.

Thence turning and running northwesterly along the northeasterly side of Manton Avenue to its intersection with the northwesterly side of Delaine Street.

Thence turning and running southwesterly along the projected northwesterly side of Delaine Street to its intersection with the northerly side of Hartford Avenue.

Thence running easterly along the northerly side of Hartford Avenue to the projected westerly line of Service Road #1.

Thence turning and running southerly along the westerly side of Service Road #1 and across Plainfield Street to the southerly side of Plainfield Street.

Thence turning and running northeasterly along the southeasterly side of Plainfield Street to its intersection with the southwesterly side of Atwood Street.

Thence turning and running southeasterly along the southwesterly side of Atwood Street to its intersection with the projected northerly line of Lot 99 on Assessors Plat 105.

by a Unanimous Rising Vote, on motion of
COUNCILMAN LOMBARDI, seconded by
COUNCILMAN IGLIOZZI.

The motion for Passage, is Sustained.

PERSONAL PRIVILEGE

COUNCILMAN LOMBARDI requests the privilege of the Floor to speak on a Point of Personal Privilege and states:

"Mr. President, I know it is a long evening but there is certainly something that has to be done and it is perhaps a sad evening but also a happy one and that is the departure of two members one from the Third Ward Member, Councilman Fenton and I want to say on behalf of I am sure several people and also to Mrs. Fenton, "you can have him back".

Only kidding, I just want to say that for the past four years I have referred to him as the "conscience of the City Council" and maybe the entire city and I think that many times you spoke from the heart and you certainly stood by your convictions and you are honest, you are a person of integrity, perform your duties professionally, and more importantly, I know you care.

Councilman, I will say this, I think that is just a weigh station for you, what we do here and I see great things for you and DEM.

But, you have a lovely wife, a bright future and most importantly you have a baby on the way and that is what it is all about. I've been around and kicked in the head quite a few times and the way to succeed is by hard work and determination

and these are qualities that you have shown over the past several years. You are a dedicated person and I know that as dedicated as you are on the City Council I know that you are dedicated to your family and I know that you are dedicated to your job and with that Councilman I just want to say Good Luck with whatever endeavor you seek and I know you will be successful. You'll always have a friend in me here, personally.

Councilman Dillon, I had the honor and the privilege with working on the City Council with you, and Sally, Sean, Ryan you are getting your husband back and your father back after 16 years. I'm sure that you won't miss getting all that mail and all those midnight phone calls anymore.

David, you are a first rate individual and you have shown leadership on this City Council that is an inspiration and I want to say that I appreciate all the help you have given to me and I know you care for your area and the constituents that you represent as well as Councilman Fenton.

Whatever endeavor that you pursue I know that you will be successful because you have proven that time, after time, after time, and I wish you the best of luck and God Bless you and your family."

COUNCILMAN FENTON requests the Privilege of the Floor to Speak on a Point of Personal Privilege and states:

"Mr. President, two events happened and I guess this probably wraps it up pretty well. Right after I had been elected I was sitting downstairs in the outer room of then Mayor Paolino's Office and I was waiting and the Mayor asked to see me, he was leaving office and he wanted to welcome me to City Hall and I was sitting out there and a much older gentleman a man in the 70's or so came out of the Mayor's Office ahead of me and he was a former Councilman, I never got his name so I couldn't tell you who it was and he said the Mayor introduced the two of us and I said "it's a pleasure to meet you" and he said "you look like a nice young boy, remember the Golden Rule, first term, you keep your mouth shut and you listen to your elders".

About a week later, I had breakfast with Mac Farmer and he said really what Andrew Annaldo said and what others have voiced and that is "when you get on the Council and you are in doubt, follow Dave Dillon. David, I didn't do a very good job. I think his sons should know that they really have a great man as a father and it is only you have served that there is a constant tugging at you between your responsibility and your desire to serve your constituents in the City and your desire to serve and be responsive to your family, and the two of you should know that there were probably many times that you wish your father were at home, but you should know that he represented the City with the finest performance of ethics and real dedication to his job and with that, you should be extremely proud and you should remember that always.

I would like to thank a number of people. First, really to my constituents, the residents of the Third Ward, they gave me that landslide victory of 16 votes. They were kind enough to take a chance on then a 26 year old when I was running and they gave me the opportunity to serve which is as much as you could ask.

To my colleagues, I thank you. You have been patient with me you have listened to me and you have sometimes even agreed with me. But, I have always found it to be a relationship, a friendship, support and I hope that the City continues to be well served. To the Clerk's Staff, and the Council Staff, especially and I don't mean to single out any one person but in this case I must, to Rita Murphy who has been a wonderful person of support. To all of the staff, to Michelle, to Dolores to Peggy, God rest her Soul, to Buddy and to Steve Woerner and to all of the Clerk's Staff, Rose, Michael and all. It has really been a wonderful relationship and you have always been extremely supportive, professional and hard working.

But, most importantly, to my wife. I had a rule with constituents I said don't wait until the next day to call me about a problem that is happening that night. If it's a drug dealer dealing drugs, or Johnson and Wales Students keeping you up, I want you to call me that evening irregardless of the time and no exaggeration, there were probably 50 to 100 times in which I responded to phone calls after midnight.

The Third Ward is not like the East Side. The Third Ward is a different neighborhood, it is a tough neighborhood and it has many problems. It has problems that only other certain neighborhoods in the City of Providence understand. It took a very supportive and wonderful wife to be able to do this.

I can remember coming back from meetings disgusted and frustrated and there was always a supportive wife there. My wife Julie is the love of my life and I look forward with spending more and more time with her and our new child if he/she will ever come.

There will be some extremely fond remembrance. Councilwoman Nolan mentioned the tax fight of 1992. I think that was an important step for the City of Providence to gain a focus on the City's financial situation and I think it still has a long way to go and I am especially proud of it and on another level I think probably Vincent

A. Cianci, Jr.'s greatest legislative defeat and I will take great pride in that as well. As a Councilman, I had promised to do a number of things when I was elected and I was looking at those things recently on one of my brochures and I promised a gymnasium . . . at the Parks and a couple of other things that I am proud to say at the completion of my four years, that those things are done and I have great satisfaction in that.

I was the Minority Leader of the City Council and I took that job extremely. I think that is an important role in one that if you are appointed and have a democracy, it only works with a two party system and that minority voice is an important one. I know it is often frustrating that I need everything, from parliamentary procedures to void committees to hold things up, to send things back and forth, but I believe that that was my role and my responsibility and that as a Minority Leader is your job. It is not to be an obstructionist but it is to make sure that the rules are followed and all is fair. There were times in which this job was very difficult and unless you do not understand it . . . being followed day and night to other things equally less pleasant as some of us have reported; harrasing mail and death threats. That is not the way it should be.

I haven't seen anyone on this Council using their position for political gain or personal gain and they did it to serve, and I hope I did that as well. I'm proud to say I don't think I am any

more financially wealthier because of my service. I rejected pensions and didn't take the allowance and I think that those were important steps.

I will miss this. I have lived in the City of Providence since the age of 7 until now, I'm 32 years old and I've lived in the same 7 block area for almost all of those years except for College and a stint in Washington, DC.

It's a great neighborhood, it's a great City but from my standpoint it was time to go on to new things and try new things and this is one of the ways to break out of . . . I felt that if I stayed in the City of Providence there would always be that temptation to get back into the Electoral Politics of Providence which has consumed all of us and I didn't want that to always be holding over my head and that was an important step for me. But, to all of you I thank you. It has been an honor and privilege to serve and it's been an honor and a privilege to develop the friendships that I have with you and I wish those of you who are returning to the Council the greatest of luck dealing with what I think are some very serious problems and to Councilman Dillon, my colleague, I wish you the best at your retirement as well and to all the staff of the City that I appreciate your support and I know that most times the effort was always made on behalf of the people of the City of Providence. Thank you Mr. President."
