AN ACT

IN AMENDMENT OF AND IN ADDITION TO SECTION 28-9.1-5 OF THE
GENERAL LAWS OF THE STATE OF RHODE ISLAND, 1956, AS AMENDED.

It is enacted by the General Assembly as follows:

SECTION 1. Section 28-9.1-5 of the General Laws of the State of Rhode Island, 1956, as amended, is hereby further amended to read as follows:

28-9.1-5. Recognition of Bargaining Agent.--The labor organization selected by the majority of fire fighters in any city or town shall be recognized by such city or town as the sole and exclusive bargaining agent for all of the members of the city or town fire department unless and until recognition of such labor organization is withdrawn by a majority of the fire fighters. The labor organization or city or town may designate any person or persons to negotiate or bargain in its behalf.

SECTION 2. This act shall take effect upon its passage and all acts or parts of acts inconsistent herewith are hereby repealed.

AN ACT

IN AMENDMENT OF SECTION 28-9.2-6 OF THE GENERAL LAWS OF THE STATE OF RHODE ISLAND, 1956, AS AMENDED.

It is enacted by the General Assembly as follows:

SECTION 1. Section 28-9.2-6 of the General Laws of the State of Rhode Island, 1956, as amended, is hereby further amended to read as follows:

28-9.2-6. Obligation to bargain.--It shall be the obligation of the city or town, acting through its corporate authorities, to meet and confer in good faith with the designated representative or representatives of the bargaining agent, including any legal counsel selected by the bargaining agent, within ten (10) days after receipt of written notice from said bargaining agent of the request for a meeting for collective bargaining purposes. This obligation shall include the duty to cause any agreement resulting from negotiations to be reduced to a written contract, provided that no such contract shall exceed the term of three (3) years.

SECTION 2. This act shall take effect upon its passage and all acts or parts of acts inconsistent herewith are hereby repealed.

AN ACT

IN AMENDMENT OF 11-5-5, GENERAL LAWS OF RHODE ISLAND, 1956, AS AMENDED, RELATIVE TO ASSAULT OF POLICE OFFICERS AND FIREMEN.

It is enacted by the General Assembly as follows:

SECTION 1. Title 11, Chapter 5, Section 5 of the General Laws of Rhode Island, 1956, as amended, is hereby amended to read as follows:

"11-5-5. Assault of Police Officers and Firemen.--

Any person who shall knowingly and wilfully strike or attempt to strike a uniformed member of the state police, metropolitan park police, conservation officers, state properties patrolman, or city or town police forces or fire departments while the member is engaged in the performance of his duty shall be deemed to have committed a felony, and shall be imprisoned not exceeding three (3) years or fined not exceeding fifteen hundred (\$1500) dollars or both."

SEC. 2. This Act shall take effect upon its passage, and all acts or parts of acts inconsistent herewith are hereby repealed.

28-9.2-5. Recognition of Bargaining Agent.--The organization selected by the majority of the policemen in any city or town shall be recognized by such city or town as the sole and exclusive bargaining agent for all of the policemen of the city or town police department unless and until recognition of such organization is withdrawn by vote of a majority of said policemen of said city or town. The organization or the city or town may designate any person or persons to bargain on their behalf.

SECTION 2. This act shall take effect upon its passage and all acts or parts of acts inconsistent herewith are hereby repealed.

28-9.1-6.
