EXPERIENCE OVERVIEW:

I have 31 years of experience in the design and construction fields in both commercial and residential projects. For the past two years I have worked at the Department of Inspection and Standards for the City of Providence. In addition to the regular duties of this position I have had the opportunity to work with several of the City departments to create a fluid, more cohesive permitting and plan review process, which is more transparent to the public.

Before joining the City of Providence, I worked with Premier Development, Inc., whereupon I brought several projects from inception to completion. The projects developed by the firm range in size from 1-3 million with one large scale project projected at 25 million dollars. The projects vary in type; including residential condominium developments, medical office buildings, historic restoration, renovation and new construction.

Previously, I was partner in the firm Berry/Lykins Architects. At Berry/Lykins I was involved in various projects: historic preservation, renovation, adaptive reuse, liturgical design, new construction, commercial and residential. While at Berry/Lykins the firm won a design competition for the Newport National Golf Club, received a preservation award from the Newport Historic Society, a certificate of merit from the Providence Preservation Society, and was a guest on "At Home with Bob Vila" the television series. Another interesting opportunity presented itself when one of my former rock climbing students recommended me to an organization that wanted to build the largest climbing gym in the United States. Upon completion of this gym they hosted the US Nationals Rock Climbing Competition.

In previous firms I have had the opportunity to design a very extraordinary custom home on the coast of Bradenton, Florida. Also I won a design competition with an unusual open-air US Post Office design that was built for the town of Longboat Key. Additionally I worked as the research architect for the master plan for the University of the Virgin Islands.
