ORDINANCE SECOND READING

The following Ordinance was in City Council October 4, 2001, Read and Passed the First Time and is returned for Passage the Second Time, as amended:

An Ordinance in amendment of Chapter 2000-25, approved August 9, 2000, of the Ordinances of the City of Providence making an appropriation of four hundred eighty five million, seven hundred seventy two thousand, eight hundred sixty dollars (\$485,772,860) for the fiscal year ending June 30, 2002, as amended.

Be it ordained by the City of Providence:

Now, therefore, be it ordained by the City of Providence:

Section 1. To defray the expenses of the City of Providence for the fiscal year ending June 30, 2002, the sums of money or so much thereof, as are authorized by law, indicated in the accompanying schedule, are hereby appropriated for the objects and purposes, and in amounts expressed therein provided that payments thereunder shall be subject to the provisions of the Home Rule Charter of 1980, validated by the General Assembly of the State of Rhode Island at its January Session, A.D., 1981 and approved November 4, 1980, and subject to the provisions of the City Ordinances relative to the expenditures of money from the City Treasury. Fiscal Assistance to State and Local Governments rules and regulations shall govern the portion of this Budget so designated.

Section 2. The payments to the School Fund of the following estimated receipts included in the appropriation of \$253,603,475 for the support of the Public Schools for the City of Providence fiscal period 2001-2002, will be increased or decreased to conform with the actual amounts received from such sources during the City of Providence fiscal year 2001-2002.

Section 3. Any transfer to the General Fund from Expendable Trust Funds shall be restricted to and deemed to be utilized for the reduction of debt obligations of the City of Providence, as provided for in Section 808 of the Home Rule Charter.

Section 4. The provisions included in this ordinance supersede any prior ordinances or any provisions thereof.

Section 5. Notwithstanding the provisions of Section 17-185 and Section 17-186 of the Code of Ordinances, the amount of \$23,001,771 is hereby appropriated to the Pension Accumulation Fund, reflecting a 30-year amortization of the pension liability and the second year of a four-year plan to appropriate the actuarial assumption.

Section 6. The property tax revenue shown in the ordinance was based on new property assessments as of December 31, 2000. These

valuations were determined using one or more of the following appraisal valuation methodologies (cost approach, income approach, sales comparison approach): a.) Residential property assessments were determined by employing a cost and sales comparison, also known as a "market approach." b.) Commercial and industrial property assessments, including apartments, were determined by using a cost and income approach. c.) Vacant land assessments were determined by analyzing various types and sizes of land found in Providence neighborhoods and commercial areas. Residual indications of land values were also studied, and based on those analyses; tables were developed for land valuation. This approach is best described as an application of the sales comparison approach. d.) Special purpose properties were valued by one or more of the above-described approaches. e.) Tax-exempt property assessments were generally valued using the cost approach.

Section 7. The line item for overtime is to be used for planned public events that occur outside the employees work schedules, public safety, and emergency related purposes. Non-union employees shall not be entitled to overtime.

Section 8. The funding for any position that becomes vacant during the fiscal year for any reason shall only be used to offset "breakage" until such time that breakage is zero (0). The City Council may reapportion this amount by amendment.

Section 9. Any salary increase shall take effect June 30, 2002 and the remainder of the Ordinance shall take effect upon its passage.

LINE ITEMS VETO BY HIS HONOR, THE MAYOR

Communication dated October 29, 2001, Informing the City Clerk of his line items Veto on the following Ordinances:

Section 7, Section 8 and Section 9 of "An Ordinance in amendment of Chapter 2000-25, approved August 9, 2000, of the Ordinance of the City of Providence making an appropriation of four hundred eighty five million, seven hundred seventy two thousand, eight hundred sixty dollars (\$485,772,860) for the Fiscal Year Ending June 30, 2002, as amended.

Section 7 of the Appropriation Ordinance states, "The line item for overtime is to be used for planned public events that occur outside the employees work schedules, public safety, and emergency related purposes. Non-union employees shall not be entitled to overtime." This provision is too restricted in that it

unnecessarily ties the hands of the executive when it is confronted with circumstances which in its judgment require the use of overtime to effectively perform services in the public interest. Additionally, non-union employees may not be barred from receiving overtime; state labor laws set forth rules regarding overtime even when an employee is not covered by a collective bargaining agreement. Consequently, he is constrained to veto Section 7 of the Appropriation Ordinance.

Section 8 of the Appropriation Ordinance states that "The Funding for any position that becomes vacant during the fiscal year for any reason shall only be used to offset "breakage" until such time that breakage is zero (0). The City Council may reapportion this amount by amendment." This provision is unacceptable. The executive must be free to fill funded

positions at any time so that necessary city services may be performed effectively. Consequently, he has also vetoed Section 8 of the Appropriation Ordinance.

Section 9 of the Appropriation Ordinance states, in part, that "any salary increase shall take effect on June 30, 2001 . . ." This provision is problematic in that the administration is currently engaged in collective bargaining with the various public employee bargaining units

and, consequently, a provision of this kind at this time would needlessly address a subject which is properly part of the collective bargaining process. The City Council will have an opportunity to ratify collective bargaining agreements upon completion of negotiations. Therefore, he has vetoed Section 9 of the Appropriation Ordinance.

Section 1. The afore described Compensation Plan is hereby adopted for all City Officers and employees and shall be applied to each, except as hereinafter provided.

Section 2. The salary for each position is categorized as one (1) of sixty-five (65) "Pay Grades", each of which contains five (5) "Steps". The "Pay Grades" and "Steps" are enumerated and set forth in Table I (Grade 1 — Grade 35) and Table II (Grade A1 — Grade A30).

Section 3. Notwithstanding any other provision of this Ordinance, any and all employees in the Office of the Mayor shall be excepted from any salary established herein so long as the total of the compensation for such employees does not exceed the annual budget appropriation for personnel services in the office of the Mayor.

Section 4. Notwithstanding any other provisions of this Ordinance, the compensation for positions approved by the Salary Review

Commission and legal assistants to the City Solicitor shall be no greater than those herein specified; however, any department head or legal assistant to the City Solicitor may be compensated at a rate lower than that established herein, and that lower compensation shall be allowed by this Ordinance.

~~Section 5. The Cultural Affairs Coordinator is a salaried employee and not entitled to overtime.~~

Section 6. The provisions of this ordinance shall not be construed as a ratification of any collective bargaining agreement.

Section 7. ~~Any salary increase shall take effect June 30, 2002 and the remainder of the Ordinance shall take effect upon passage.~~

LINE ITEMS VETO BY HIS HONOR, THE MAYOR

Communication dated October 29, 2001, Informing the City Clerk of his line items Veto on the following Ordinances:

Section 5 and Section 7 of "An Ordinance establishing a Compensation Plan for the City of Providence and repealing Ordinance Chapter 2000-26, approved August 9, 2000, as amended".

Section 5 of the Compensation Ordinance states that the "Cultural Affairs Coordinator . . . is not entitled to overtime." As previously stated, state labor laws regulate the payment

of overtime. Consequently, likewise, he is constrained to veto Section 5 of the Compensation Ordinance.

Section 7 of the Compensation Ordinance is identical to the language of Section 9 of the Appropriation Ordinance. For the reason he has proffered for his veto of Section 9 of the Appropriation Ordinance, he has likewise vetoed Section 7 of the Compensation Ordinance.

Section 60. The number of employees in the Office of the Mayor shall not be limited. The Mayor may appoint without reference to civil service provisions and without the necessity for approval by the City Council a Chief of Staff and such Deputies, Assistants, Aides, Secretaries, Stenographers, Clerks and other personnel as he may deem necessary.

Section 61. No person shall be appointed to, and the City Treasurer shall not pay, nor shall an officer or employee of the city issue a check for the payment of, nor pay any salary or compensations to a person holding or claiming to hold a position in the classified service in any department which is in excess of the total number of funded positions or the number of any individual class of positions provided herein for the particular department; provided, however, that with the approval of the department head and the Director of Finance, said maxi-

mum may be exceeded temporarily when regular employees are absent on vacation and the excess employees do not aggregate more than the number on vacation or during the absence of employees, due to injuries received while discharging their duties as employees or during absences of employees on sick leave and it is necessary to employ temporary employees for the duration of the employees sick leave, or during the absence of employees who have been granted a temporary leave of absence or when in the opinion of the Director of Finance, a temporary emergency exists.

Section 62. Where no maximum limit is fixed on the total number of positions or the number of any individual class of positions in a department, the number of persons appointed and employees shall be determined by the unexpended appropriation available.

Section 63. Chapter 2000-21 of the Ordinances of the City of Providence approved August 9, 2000, with all amendments and additions thereto, is hereby repealed and all other Ordinances or parts thereof inconsistent herewith are likewise repealed.

Section 64. The provisions of this ordinance shall not be construed as a ratification of any collective bargaining agreement.

Section 65. This Ordinance shall take effect upon its passage.

An Ordinance to authorize the issuance of general obligation refunding bonds of the City of Providence to refund the outstanding portion of \$35,150,000 general obligation bonds dated January 15, 1993, due January 15, 1994 to 2013, inclusive.

Be it ordained by the City of Providence:

Section 1. The City of Providence (the "City") has previously issued its \$35,150,000 General Obligation Bonds dated January 15, 1993; due January 15, 1994 to 2013, inclusive, of which \$21,070,000 remains outstanding (the "Prior Bonds"); and

Section 2. The City desires to issue general obligation refunding bonds (the "Refunding Bonds") to refund the Prior Bonds in order to take advantage of the lower interest rates which currently are prevailing;

Section 3. The City is authorized pursuant to Chapter 12 of Title 45 of the General Laws of Rhode Island, as amended, to issue its Refunding Bonds to pay all or any designated part of an issue of bonds then outstanding, including principal, redemption premium, if any, interest on the outstanding bonds coming due on or prior to the date on which those bonds are to be redeemed, and the cost of issuing the Refunding Bonds.

Section 4. The City has determined that refunding some or all of the outstanding Prior Bonds in order to obtain debt service savings would result in financial benefits to the City.

Section 5. It is hereby declared that the Refunding Bonds authorized hereby will be within all debt and other limitations prescribed by the Constitution and laws of the State of Rhode Island.

Section 6. The City is hereby authorized to issue its General Obligation Refunding Bonds in an amount necessary to refund some or all of the outstanding Prior Bonds and to provide for any principal, redemption premium, and interest on the outstanding Prior Bonds coming

due on or prior to the date on which those Prior Bonds are to be redeemed, and the costs of issuance.

Section 7. The manner of sale, denominations, maturities, interest rates and other terms, conditions and details of the Refunding Bonds shall be determined by the City Treasurer and the Mayor.

Section 8. The City Council hereby authorizes the City Treasurer, with approval of the Mayor, to issue Refunding Bonds for the purposes set forth herein and to take all actions as he deems necessary to effect the issuance of the Refunding Bonds. The Refunding Bonds shall be issued by the City under its corporate name and seal or a facsimile of such seal. The Refunding Bonds shall be signed by the manual or facsimile signature of the City Treasurer and the Mayor.

Section 9. The City Treasurer and the Mayor are hereby authorized to issue the Refunding Bonds and deliver them to the purchaser and said officers are hereby authorized and instructed to take all actions, on behalf of the City, necessary to ensure that interest on the Refunding Bonds will be excludable from gross income for federal income tax purposes and to refrain from all actions which would cause interest on the Refunding Bonds to become subject to federal income taxes.

Section 10. The proceeds arising from the sale of such Refunding Bonds, exclusive of any premium, accrued interest and costs of issuance, shall, upon the receipt be paid immediately to the paying agent or paying agents for the Prior Bonds, and such paying agents shall hold the proceeds in trust until they are applied to pay or refund the Prior Bonds. While such proceeds are held in trust, they may be invested as

permitted by Chapter 12 of Title 45 of the General Laws of Rhode Island, as amended.

Section 11. The City's Finance Director is authorized to execute and deliver a continuing disclosure certificate in connection with the Refunding Bonds issued by the City, in such form as shall be deemed advisable by the City's Finance Director. The City hereby covenants and agrees that it will comply with and carry out all of the provisions of the continuing disclosure certificate, as it may be amended from time to time. Notwithstanding any other provision of this Ordinance or the Refunding Bonds, failure of the City to comply with the continuing disclosure certificate shall not be considered an event of default; however, any bondholder may take such actions as may be necessary and appropriate, including seeking mandate or specific performance by court order, to cause the City to comply with its obligations under this Ordinance and under the continuing disclosure certificate.

Section 12. The Refunding Bonds may be issued either alone or consolidated with other issues of notes or bonds of the City.

Section 13. This Ordinance shall take effect upon its approval by the Mayor after its passage.

Northeast shall supply the City of Providence with an insurance policy naming said City of Providence, its agents, officers, servants and employees as additional-named insureds in a sum not less than one hundred thousand dollars (\$100,000.00) which policy shall be approved by the Department of Law of the City of Providence.

11. Grantee shall not lay, construct or affix to the realty any temporary or permanent structure other than described earlier herein.

23-107. *Indemnity of city against claims arising out of electrical installations.* No right of any person to maintain, use or operate any poles, wires, cables, conduits, ducts, pipes, manholes, handholes, or other appliances or appurtenances in any street or other traveled way in the city, shall be in preference or hindrance of public work in the city, and should any of the same in any way interfere with the construction, alteration or repair of any public work in, under, or over any such street or way, whether done by the city directly or by any contractor for the city, such person shall at his own expense protect, alter or move any of the same so interfering to some other location, or discontinue the use and operation thereof for the time being, as directed by the director of public works, without the city being liable for any damages suffered by such person thereby. The City shall notify such person not fewer than ninety (90) days prior to such public work, which will interfere with any of the same or the use or operation thereof. In case such person shall fail to comply with any such direction of said director, the city may protect, alter or move the same, and recover the cost thereof from such person.

23-108. *Precedence of wires, apparatus of city signal service.* The wires, poles, posts, structures and supports of the telephone, fire alarm and police signal service maintained by the city shall at all times take precedence and right-of-way as to all other wires, poles, posts, structures and supports maintained or erected in the city; and no lineman or other person, either in erecting wires, poles, posts, structures or supports in any way whatsoever shall interfere with, or disturb, dissarrange or change any wires

maintained by the city, or any appurtenance thereof; and in every instance of removal of any said wires, poles, posts, structures or supports for the accommodation of any other corporation or party, or to place the same beyond danger from the electric current of any other corporation or party, the expense incident to said removal shall be paid immediately by such other corporation or party.

The city,

the city council, or the officers, agents or servants of the city, exercising the rights, powers or permission, and subject to the restrictions, respectively given and reserved herein shall not be held liable by such person or corporation on account thereof, or by reason of any injury or damage caused thereby.
