### DEPARTMENT OF LAW ANNUAL REPORT

June 23, 2005

#### INTRODUCTION

This Report is provided to the City Council and the Mayor pursuant to Home Rule Charter Section 1201(e) and Section 2-98 of the Code of Ordinances. Part I describes the organizational structure of the Department of Law. Part II summarizes major accomplishments by the Law Department in fiscal year 2004-2005. Part III of the Report describes significant case developments and important transactions closing during the fiscal year. It also gives data on cases currently pending in the Department with reference to Appendix A, listing all such cases by attorney.

#### ORGANIZATIONAL STRUCTURE

Management Team: The Law Department management structure has continued to evolve over the past year. City Solicitor Joseph M. Fernandez is the Chief Executive; he supervises the legal and administrative work of the Department; makes legal, policy and strategic decisions concerning work product; and serves as the liaison and chief counsel to the City Council and Administration. Deputy City Solicitor Adrienne G. Southgate supervises the daily operation of the office. In addition to her focus on corporate and regulatory matters, she staffs City Council and Ordinances Committee meetings.

Senior Assistant City Solicitors: Alan E. Kornstein, Kevin F. McHugh, Sara A. Rappart, William T. Smitherman, and Frederick W. Stolle, Jr. maintain significant caseloads, as well as the responsibilities delineated on the organizational chart attached hereto as Appendix A.

Assistant City Solicitors: Michael Calise, Steven L. Catalano, Kenneth B. Chiavarini, Caroline C. Cornwell, Anthony F. Cottone, Raymond Dettore, Jr., Stephanie L. Federico, Pamela B. Quigley, and Michael A. Tarro have duties outlined in the organizational chart.

Support Staff and Paraprofessionals: Sheila Sanchez, Carolyn Ranucci, Allison Chiaverini, Sharon Mulcahey, Roxanna Benitez and Gregory Marcogliese comprise the outstanding support staff for the Law Department.

## **DEPARTMENT ACCOMPLISHMENTS**

The Law Department currently operates under a set of goals and objectives which were put in place at the beginning of the current fiscal year. The goals include satisfactory resolution of claims and lawsuits against the City of Providence; accurate and timely response to the City Council and City departments requesting legal assistance and support; fulfillment of the Solicitor's Home Rule Charter obligation to ensure the ethical conduct of City officials and employees; and representation of the City in a dispassionate, professional and competent manner. The objectives include enhancement of the Law Department's reputation and the respect accorded to its members in the courts, conference rooms and board rooms of the City; and the training and mentoring of the next generation of municipal attorneys.

During the past year, the Department continued to improve service significantly in at least six key areas: labor and employment matters, transactional advice, legislative drafting and counsel, tax and financial litigation, tort litigation, and School Department work.

Labor and Employment Matters: As with any municipal government, there is a significant need in the City of Providence for sound legal advice in the areas of labor and employment law. For many years, the City utilized outside labor and employment counsel exclusively. In this fiscal year, the City faced the triple challenges of negotiating all major union contracts simultaneously, supporting a more robust Department of Human Resources, and taking significant actions against wayward employees – all while containing costs.

With the strong encouragement of the City Council – and without creating an additional staff position – the Law Department designated an assistant city solicitor as full-time, in-house labor and employment counsel. Assistant Kenneth Chiavarini has done a yeoman's job in advising Human Resources, other City departments, and members of the City Council. He has participated in the negotiation and drafting of the primary Laborers collective bargaining agreement with Local 1033, the agreement with school crossing guards, and the school clerical-workers' contract with Rhode Island Council 94, Local 1339, and helped brief the City Council on all those contracts. On a daily basis, he advises Human Resources, Schools, and departments such as Public Works, Parks, Communications, Fire and Treasury on the administration of labor agreements, the calculation of benefits, accommodations and discipline. He has played a key role in the City's more-vigorous oversight of employee leaves under the Family and Medical Leave Act. He staffs the City Council's Residency Commission and the City Retirement Board. He advises individual City Council members on broad employment issues, such as pensions, and on employment and retirement matters for particular employees. He represents the City in labor and employment actions in the Supreme

Court, the Superior Court, the Employment Board of Review, the Rhode Island Commission for Human Rights, and the Rhode Island Department of Labor.

In addition, Law Department lawyers have led training sessions for departments on employment issues. Assistant Chiavarini has led training sessions for departments such as Planning and Development and Police on FMLA and sick leave policies. Senior Assistant Kevin McHugh has conducted a training session for Police Department commanders on how to conduct civilian complaint hearings. Senior Assistant Sara Rapport has trained School principals on progressive discipline and documentation for disciplinary action.

Transactional Advice: Every City Council committee and every City department has ongoing requirements for transactional assistance. The committees of the City Council, as well as individual members of the Council (particularly Ordinances Chair Rita M. Williams, Public Works Chair Terrence M. Hassett, Majority Leader Luis A. Aponte and Minority Leader David Segal), need assistance in researching and drafting ordinances and resolutions, including tax stabilization agreements. During the past year, this meant 62 resolutions and 167 ordinances (or amendments to existing ordinances). For some departments, such as Planning and Development, the review of contracts and leases, HUD documents, and research on bond documentation can be very complex and detailed. Parks and Public Works each provide a consistent volume of legal work, typically involving leases, easements and abandonments. Finance and Public Properties require assistance in contract negotiation and drafting.

The corporate and regulatory lawyers in the Law Department – particularly Deputy Southgate, Senior Assistant Stolle and Assistant Dettore – have undertaken to staff all of the standing City Council committees as well as provide advice and assistance to the Council and individual Council members. The Department also staffs virtually all of the City boards and commissions, as well as a number of operations boards (*e.g.*, City Plan Commission, Historic District Commission, Downcity Design Review Commission, Planning Board, Zoning Board).

Legislation: During the past 14 months, the Law Department has significantly expanded its work in drafting legislation for submission to the General Assembly, in reviewing other bills under consideration, and in providing testimony.

Since January 2005, Assistant Michael Calise has devoted roughly two-thirds of his time to the development and submission of an aggressive state legislative package. His work – which included work done as a Law Department volunteer lawyer for two months – included more than 20 initiatives, including toughening the penalties for underage drinking, increasing state aid for the maintenance of roads, creation of the Providence Development Corporation, reforming the tax sale process, allowing traffic tickets to be created electronically, and allowing zoning maps to be stored electronically.

On Saturday, April 9, 2005, Assistant Calise participated in briefing City Council members on the legislative package. He worked with State House Legislative Counsel and, along with Assistant Caroline Cornwell, testified on the proposed legislation. Assistant Stephanie Federico has also played a significant role in legislative research and drafting, crafting legislation on prostitution, massage parlors, and graffiti.

Under the supervision of Deputy Southgate, Assistant Calise has also researched and drafted ordinances for City Council members, including drafting an exception to the scooter ordinance for disabled persons for Council President John Lombardi, and research on providing City notices in Spanish for Minority Leader Segal.

Tax Litigation: During 2004, the Law Department continued to clean up the backlog of tax appeal cases. Senior Assistant Fred Stolle resolved the Narragansett Electric case, which had exposed the City to “double taxation” liability of approximately \$21,000,000.00. He resolved that matter for approximately \$7,000,000.00 over a number of years. Senior Assistant Stolle also resolved the Providence Lumber case and recovered \$900,000.00. In addition, the Department successfully utilized set-offs to recover previously uncollectible taxes and interest in the following cases:

Tort Litigation: In the area of tort claims, the Department has aggressively defended the City’s interests by use of the Recreational Use Statute, prevailing in motions for summary judgment in a number of cases.

Considering the entire universe of claims, the Law Department has closed 74% of claims filed in 2004. Where claims have been settled (a figure which does not include those moving into litigation), the average amount paid is 81% of the amount requested.

School Department: The overall School Department annual budget of nearly \$300 million reflects the magnitude of its task: the Department employs over 3,300 persons, organized in five different unions under eight collective bargaining agreements. It services 26,000 students, the vast majority of whom are from families living at or below the poverty level, and a significant number of whom have special needs. Senior Assistant Rapport heads the School Department team, working with Assistants Pamela Quigley and Kenneth Chiavarini to cover a demanding docket. The three have developed a good working knowledge of state and federal law in the areas of employment, labor, open meetings/public records, education, special education, civil rights and constitutional law.

As of the close of fiscal year 2003, the School Department relied entirely upon private counsel. Fiscal year 2005 was the first full year that the Law Department handled all School Department legal matters with only limited exceptions for labor and employment, special education and workers' compensation.

Successes this year have included representation of the School Department in the intervention by the Rhode Island Department of Education (RIDE) in Hope High School; the State Commissioner endorsed almost all aspects of the School Department's Corrective Action Plan, jointly proposed with the Providence Teachers Union. In addition, the Law Department prevailed in a federal court grant of partial summary judgment in a School employment matter; in RIDE's decision to uphold the termination of a high school teacher for cause (the first such termination by the Department before RIDE in recent history); and in three arbitrations against the Providence Teachers Union before the American Arbitration Association. Senior Assistant Rapport is currently serving as co-counsel in state court where the City is challenging the Department of Environmental Management to issue the requisite approval to build a much-needed high school in South Providence.

### **THE DEPARTMENT DOCKET**

Corporate and Regulatory Matters: Among the significant achievements on the regulatory and transactional side of the Law Department are the following:

1. Preparation of Tax Stabilization Agreements for ten different entities, including Capitol Cove, LLC ("Parcel 6"), Intercontinental Fund IV Waterplace, LLC ("Parcel 2"), some of which have been approved by the Council and implemented, with others still awaiting action by the Council.
2. Release of the forensic audit of the Parks Department, commissioned after information on an employee's embezzlement came to light, and further work with the External Advisory Group to review and implement many of the auditors' recommendations.
3. Participation in a broad-based effort to defeat the expansion of the KeySpan liquefied natural gas terminal at the Port of Providence, leading to the Federal Energy Regulatory Commission's staff recommendation that KeySpan not be allowed to make significant changes without requiring that current safety standards be met.
4. A multi-court and Council effort to salvage the Downcity District following the vitiation of that portion of the City Zoning Ordinance by a Superior Court judge, culminating in the proper re-enactment of the Downcity District ordinance and concomitant negotiation for a new apartment-and-retail complex within the District which retained the most significant historic frontage.

5. Completion of a total review and revision of the municipal Code of Ordinances.

Litigation: Senior Assistant Kevin McHugh, with the aid of Assistant Caroline Cornwell, handled two major appellate matters for the Department and the City this year. In Rivera v. City, the First Circuit upheld the District Court's grant of judgment on the pleadings in favor of the City. In Young v. City, the First Circuit, while upholding many of the City's positions won in the District Court, reversed on one ground and sent the case down for trial.

Senior Assistant Rapport prevailed in a federal court decision granting summary judgment for the City and upholding the Fire Department reorganization in 2003.

Assistant Cornwell prevailed in a case in the Rhode Island Supreme Court. Though a justice of the Superior Court had found that the City and the Water Supply Board illegally took the plaintiffs' property rights by eminent domain, the Supreme Court, on appeal, held that the plaintiffs had sued the wrong party and, thus, there was no liability by the City to the plaintiffs. But in a case in which the Supreme Court said the City had engaged in "municipal thuggery," she was unable to reverse an award of attorneys' fees to a commercial-property owner that suffered an illegal mid-cycle, selective reassessment of its downtown property in 1997.

Virtually the entire backlog of Housing Court cases was eliminated during the past fiscal year. Resources are now focused on keeping current with the wave of cases arising through the Departments of Inspections and Standards and Public Works.

The Law Department has assisted with collection of overdue police and fire detail accounts, including bringing suit where necessary. In addition, the Department has assisted the Department of Planning and Development in its collection and enforcement actions.

In last year's Annual Report, the Department optimistically reported the pending migration to a new case management system which would not only allow much better tracking of cases, but also provide a range of statistical reporting options. The Department previously used the Cycom system, but it had become unworkable. One of the assistants identified a "freeware" version from the City of Vancouver, Washington, and substantial efforts were made by the Information Technology team members and ProvStat employees to tailor this software for the Department's use. The effort was ultimately abandoned after encountering numerous constraints with the software. Cycom has since proposed an updated and greatly enhanced version of its system, and offered the City an attractive three-year package. Unless and until this expenditure is approved, however, the Department has recourse only to the outmoded and severely limited case management system.

What follows is Appendix B, listing each person's individual docket. (The dockets of all employees hired after July 1, 2004, which cannot be accommodated by the current Cycom system, are presented in a table format pending the transfer to the new database.)
