



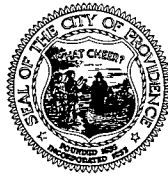

Re: Request for Waiver of Lien

This department has records for the building located at 6 Marlborough Avenue, on Assessor's Plat 45, Lot 680, indicating that the building became vacant June 5, 1975, and deteriorated to the point where the building would have undoubtedly been demolished some time early in 1977.

Boarding liens totalling \$482.50 were placed on the property by this department in order to keep the property secure, pending demolition. In 1977, Mr. Mitchell purchased this property and restored it to an occupied dwelling.
