Resolved,

That

the City Treasurer, acting under the direction of the Committee on Finance, be and he hereby is authorized and directed to borrow from time to time, in such sums as may be necessary, not exceeding ONE MILLION (\$1,000,000) DOLLARS, in accordance with the provisions of Chapter 3360 of the Public Laws, 1954, entitled "An Act Authorizing the City of Providence to Issue Bonds in the Sum of One Million (\$1,000,000) Dollars for the Reconstruction of Highways in said City in cooperation with State and Federal Governments", and to issue the city's notes therefor, bearing interest at a rate not to exceed $3\frac{1}{2}\%$ per annum, signed by him and countersigned by the Mayor and Chairman of the Committee on Finance, and to renew any such notes from time to time as the same become due, the money thus obtained shall be used exclusively for the reconstruction of highways in the City of Providence in cooperation with the State of Rhode Island and the United States of America in the extension of the Dennis J. Roberts Expressway along Huntington Avenue to the Cranston City line.

AND BE IT FURTHER RESOLVED THAT, the City Treasurer of the City of Providence is hereby authorized upon approval by the Finance Committee of the City of Providence to pay over to the State of Rhode Island so much of said fund as may be required by the State Treasurer from time to time, for the purposes aforesaid.
